Plain-27 28 tiffs moved for preliminary injunction on Counts I and II on June 11, 2020. (ECF No. 38.)

1	On June 18, 2020, the California Legislature enacted AB 860. (ECF No. 54.) Plaintiffs are
2	authorized to state on behalf of Defendants Newsom and Padilla as follows: "As previously
3	stated in their filings, Defendants confirm that Executive Order N-64-20 has been super-
4	seded by AB 860; as a result of the enactment of AB 860, Defendants will not rely upon
5	Executive Order N-64-20 in connection with the November 2020 election." (See ECF No.
6	59 at 7.)
7	Accordingly, Plaintiffs hereby voluntarily dismiss this action. Plaintiffs and Defend-
8	ants Newsom and Padilla agree that they will bear their own attorneys' fees, expenses,
9	and costs.
