**THUMBDRIVES BY CLARK COUNTY**


22 This matter comes before the Court on Contestants' Motion to Compel and/or Show  
23 Cause Regarding Production of Thumbdrives by Clark County and Clark County's Opposition to  
24 the Motion to Compel, both filed on December 2, 2020.

25 The Court in its Order of November 30, 2020, allowed for the inspection of the sealed  
26 container of testing equipment and programs pursuant to Nevada Revised Statutes ("NRS")  
27 293B.155. Under NRS 293B.155, there is no right for the release of proprietary information. As  
28 such, Contestants' Motion to Compel is denied.

1 Therefore, based on the foregoing and good cause appearing,

2 **IT IS HEREBY ORDERED** that Contestants' Motion to Compel and/or Show Cause  
3 Regarding Production of Thumbdrives by Clark County, filed on December 2, 2020, is DENIED.


