**UPON THE READING AND FILING** of the Affirmation of John Ciampoli, Esq. dated February 2, 2021, the Petition of Claudia Tenney, pursuant to Sections 16-100, 16-102, 16-106, 16-112 and 16-113 of the Election Law, sworn to the 4th of November, 2020, with proof of service on the Respondent Oswego County Board of Elections, the Respondent Oneida County Board of Elections, the Respondent Cortland County Board of Elections, the Respondent Madison County

**ORDERED** that the Respondents County Boards, the Respondent New York State Board of Elections, the Respondent Candidate Keith D. Price, Jr., and the Respondent Candidate Anthony Brindisi show cause before the Honorable Scott J. DelConte, on February 5, 2021, at 10:00 A.M., in Virtual Courtroom, via Microsoft Teams, at the Oswego County Courthouse, ~~25 East Oneida Street, Oswego, New York, 13126~~, as to why this Court should not:

1. Direct the Oneida County Board of Elections to certify the canvass of the vote and the results submitted to this Court in response to this Court’s Order of January 29, 2021 (Dkt. No. 187) and transmit those results to the Respondent New York State Board of Elections,
2. Direct the New York State Board of Elections to certify the canvass of the returns for Member of Congress, 22nd District of New York State held on the 3<sup>rd</sup> day of November, 2020, forthwith upon receipt of certified results from the Respondents County Boards of Elections as submitted to this Court in response to the Court Order of January 29, 2021 (Dkt. No. 187), and it is further

**ORDERED** that service of this Order and the papers on which it is granted by the New York State Courts Electronic Filing (“NYSCEF”) on counsel for the Respondents County Boards,

the Respondent New York State Board of Elections, the Respondent Candidate Keith D. Price, Jr.,  
and the Respondent Candidate Anthony Brindisi, on or before 10:00 A.M. on February 3, 2021,
