NOTICE OF MOTION

PLEASE TAKE NOTICE that on a date and time determined by the Court, Contestee Angie Craig will move the Court for entry of an order as set forth below.

MOTION

Pursuant to Minnesota Rule of Civil Procedure 12.02, Contestee Angie Craig respectfully moves the Court for an order dismissing the Notice of Contest. At the outset, the Court is precluded from exercising jurisdiction over this action because Contestants fails to file the Notice of Contest in the proper venue and their Notice of Contest does not demonstrate that Contestants are eligible to assert this contest. The Court also lacks jurisdiction because the allegations in the Notice of Contest do not indicate that any irregularities in the election process altered the outcome of the election for Minnesota's second congressional district.

The motion is based upon all the files, records, and proceedings herein, and upon a memorandum of law, supporting declaration, supporting affidavits and exhibits to be filed in accordance with the Minnesota General Rules of Practice.
