On September 23, 2020, we released a report detailing how Democrats across the country were pushing last-minute changes to state election laws and procedures.¹ We warned that these dangerous initiatives would increase the risk of election-related crimes and errors, undermine the integrity of the electoral process, and cause lingering uncertainty about the results of the election for several days or weeks after Election Day. Democrats ignored this report, but many of our predictions have unfortunately come true.

In September, the Democrat majority on the Pennsylvania Supreme Court unilaterally extended the deadline to receive mail-in and absentee ballots by three days after Election Day and directed that ballots received without a postmark would be presumed to have been received timely.² We warned in our report that this change would create “considerable risk for uncertainty and litigation”—and it did.³ Litigation about this last-minute change is currently pending before the U.S. Supreme Court,⁴ and Pennsylvania is still counting mail-in and absentee ballots.⁵ In


