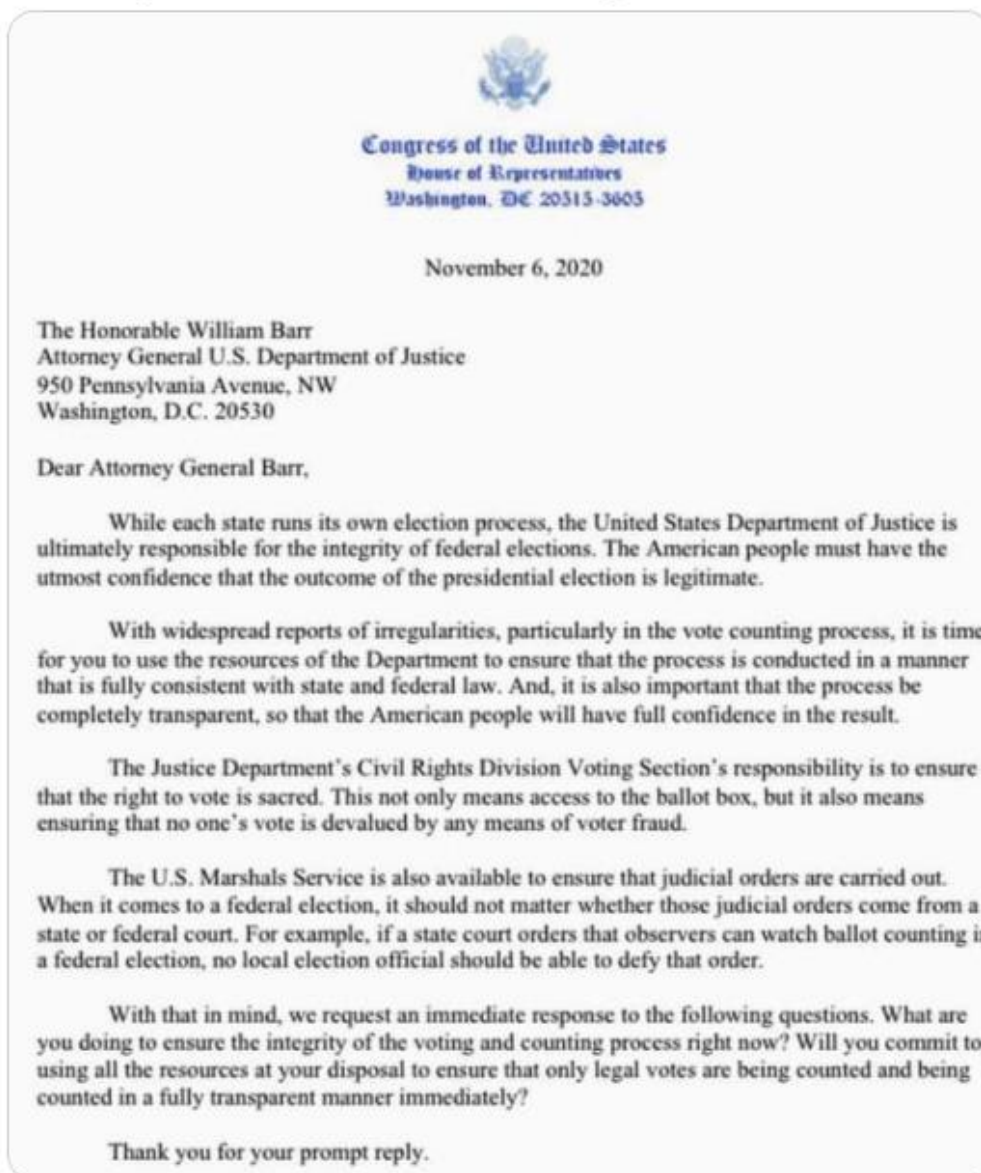

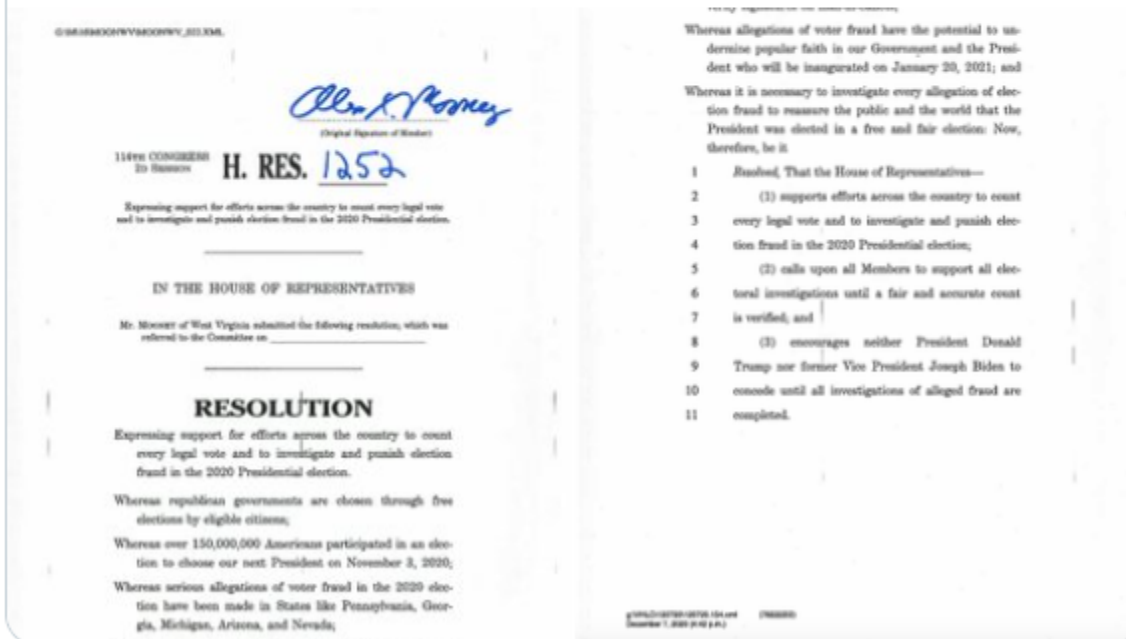

“We need to learn from these events as a country. We have seen too much unrest this past year. Republicans have been unified in condemning violence and destruction in left-wing cities across the country while Democrat mayors and governors let mobs rule the streets. Where were Democrat leaders during the rioting, looting, burning, fighting, and attacks on police by Antifa and BLM? On January 6th, the U.S. House and U.S. Senate will meet in joint session to accept the results of the Electoral College. My office has received a lot of calls asking about my position on this. My position is clear:

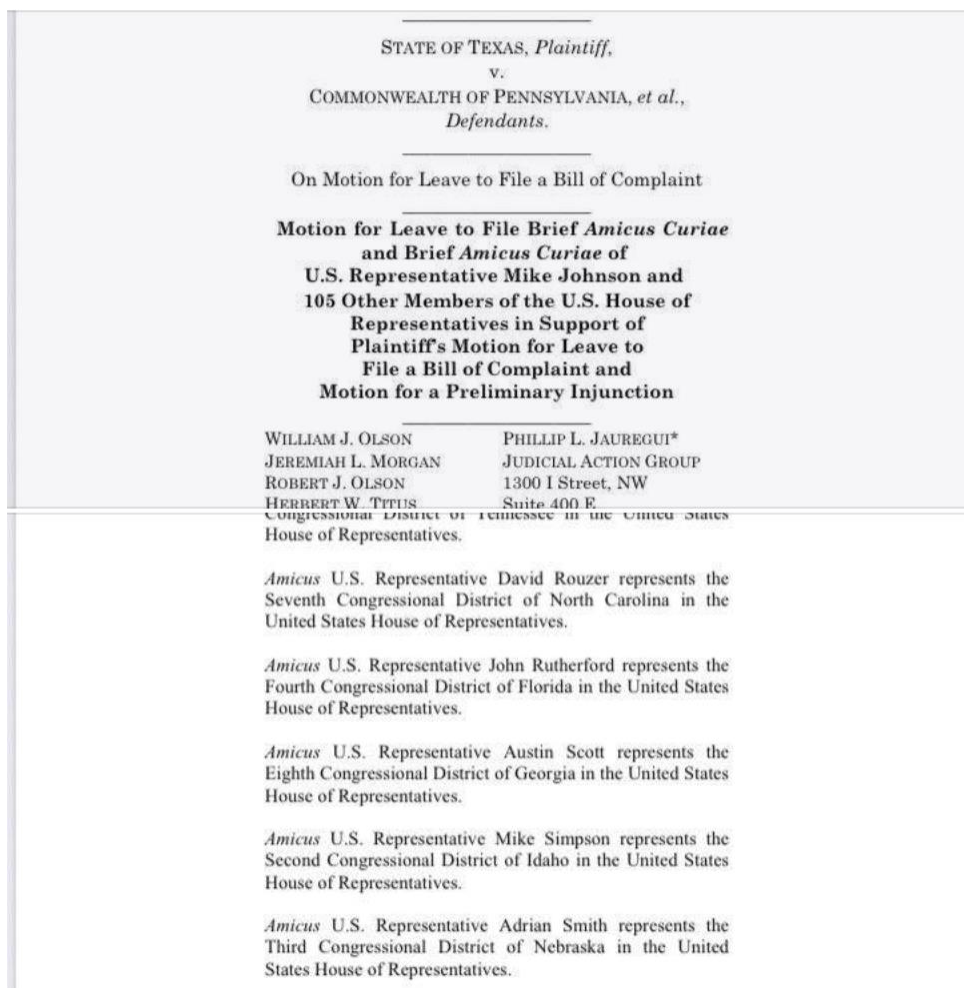

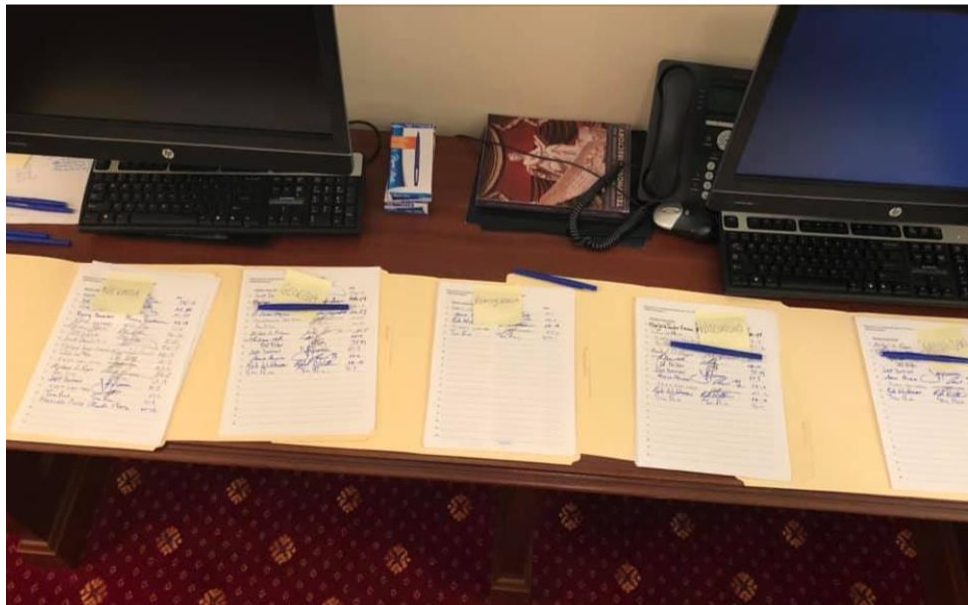
