**DEFENDANT'S MOTION TO** SUSPEND PRELIMINARY **INJUNCTION PENDING APPEAL** 

**EXPEDITED REVIEW** REQUESTED

Pursuant to Mont. R. App. P. 22(1)(a)(iii), Defendant Secretary of State Christi Jacobsen moves the Court to suspend the injunction it entered on April 6, 2022, against HB 176 and SB 169 during Defendant's pending appeal to the Montana Supreme Court. Additionally, the Secretary requests the Court modify the injunction it entered against the provisions of SB 169, HB 506, and HB 530 that were not challenged by the Plaintiffs in this lawsuit (i.e., HB 169 § 1, HB 169 § 3, HB 169 § 4, HB 506 § 1, HB 506, § 3, and HB 530 § 1). In support of this request, the Secretary submits the accompanying brief.

The injunction upends the status quo, imposes a severe burden on Montana's election officials, and would result in significant voter confusion regarding Montana election law at the same time Montana is preparing to conduct state-wide elections. The Court should exercise its considerable discretion—and delay these unnecessary consequences—by suspending the injunction while the Montana Supreme Court considers the Secretary's pending appeal. Expedited review of this Motion is requested because of Montana's rapidly-approaching elections. Counsel for all Plaintiffs' have been contacted and oppose this Motion.
