The parties to this Response note that Plaintiffs and certain Defendants submitted extensive briefing at the motion to dismiss phase (*see, e.g.*, ECF Nos. 107-1, 120, 175-1, 176, 197, 198) and that Plaintiffs and certain Defendants, including four Supervisors of Elections, submitted extensive summary judgment briefing (*see* ECF Nos. 315, 320, 321-1, 326). Also, the parties to this Response reasonably anticipate that certain Defendants, including some Supervisors of Elections, will file responses affirmatively opposing Plaintiffs' Motion for Partial Summary Judgment.

The parties to this Response do not affirmatively oppose or join Plaintiffs' Motion for Partial Summary Judgment (ECF No. 320) and file this Response within the timeframe required by Local Rule 56.1(C) to aid the Court in avoiding any delay in adjudicating the motion that may have resulted if these parties had

filed no response. If the Court determines that any of the challenged provisions of SB 90 violate federal law, the parties to this Response request the opportunity to provide additional briefing regarding the timing and feasibility of specific remedies the Court might order, as well as the impact of those remedies on the administration of elections.
