PLAINTIFFS' RESPONSE TO SUPREME COURT'S SHOW CAUSE ORDER OF JAN. 2, 2024

On January 2, 2024, this Court issued an Order directing the "parties to show cause why the court should not consolidate this case with Case No. 125,084" and to file any responses no later than January 16, 2024. Counsel for Plaintiffs only became aware of the January 2 Order when Defendants served Plaintiffs' counsel with Defendants' Response, which was filed yesterday, January 16, 2024, and which referenced the Order Plaintiffs promptly contacted the Clerk's Office to obtain a copy of the Order and were provided a copy this morning. Having now reviewed the January 2 Order to Show Cause, Plaintiffs do not object to consolidation. It was not clear from the face of the Order whether the Court anticipated a response from the parties if they do not object; however, Plaintiffs file this response in an abundance of caution to provide the Court with their position.

In the same January 2 Order to Show Cause, this Court notified the parties that it intended to schedule oral arguments on February 20, 2024, if consolidation occurs. In light of the lengthy history of this case and the variety of issues involved, many of which this Court heard argument on in prior stages of the dual appeals that are now poised to be consolidated, Plaintiffs respectfully request clarification from the Court as to the issues that it would like to hear argument on should it be set for February 20. That clarification

will help ensure that the parties are best prepared to address the specific issues that the Court intends to address at that argument.
