Stat. § 813.02, Plaintiffs hereby move this Court for an order: 1) enjoining Defendant from issuing any further rules or guidance inconsistent with Wisconsin's voting statutes; 2) suspending the use of WEC's Memos dated March 31, 2020 and August 19, 2020 pending a final resolution of the legal questions Plaintiffs have raised on the merits; and 3) directing Defendant to inform municipal clerks across the state within 10 days of this Court's order that the guidance reflected in those two Memos is suspended pending the result of this litigation.

The grounds for this motion are that Plaintiffs are likely to succeed on the merits of their claim and that Plaintiffs will suffer irreparable harm in the absence of a preliminary injunction while these issues are litigated on the merits. The support for this motion is set forth in the accompanying brief and materials filed herewith, as well as in Plaintiffs' summary judgment materials also filed on today's date.
