## A BILL TO BE ENTITLED

AN ACT

- 2 relating to election integrity and security, including by
- 3 preventing fraud in the conduct of elections in this state;
- 4 increasing criminal penalties; creating criminal offenses.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 ARTICLE 1. GENERAL PROVISIONS
- 7 SECTION 1.01. SHORT TITLE. This Act may be cited as the
- 8 Election Integrity Protection Act of 2021.
- 9 SECTION 1.02. PURPOSE. The purpose of this Act is to
- 10 exercise the legislature's constitutional authority under Section
- 11 4, Article VI, Texas Constitution, to make all laws necessary to
- 12 detect and punish fraud.
- 13 SECTION 1.03. FINDINGS. The legislature finds that:
- 14 (1) full, free, and fair elections are the
- 15 underpinnings of a stable constitutional democracy;
- 16 (2) fraud in elections threatens the stability of a
- 17 constitutional democracy by undermining public confidence in the
- 18 legitimacy of public officers chosen by election;
- 19 (3) reforms are needed to the election laws of this
- 20 state to ensure that fraud does not undermine the public confidence
- 21 in the electoral process;
- 22 (4) the reforms to the election laws of this state made
- 23 by this Act are not intended to impair the right of free suffrage
- 24 guaranteed to the people of Texas by the United States and Texas

- 1 Constitutions, but are enacted solely to prevent fraud in the
- 2 electoral process and ensure that all legally cast ballots are
- 3 counted. Integral to the right to vote is the assurance of voter
- 4 access and the right for all votes legally cast to be counted;
- 5 (5) additionally, preventing a valid vote from being
- 6 counted violates the basic constitutional rights guaranteed to each
- 7 citizen by the United States Constitution; and
- 8 (6) providing for voter access and increasing the
- 9 stability of a constitutional democracy ensures public confidence
- 10 in the legitimacy of public officers chosen by election.
- 11 SECTION 1.04. Chapter 1, Election Code, is amended by
- 12 adding Section 1.0015 to read as follows:
- Sec. 1.0015. LEGISLATIVE INTENT. It is the intent of the
- 14 legislature that the application of this code and the conduct of
- 15 <u>elections be uniform and consistent throughout this state to reduce</u>
- 16 the likelihood of fraud in the conduct of elections, protect the
- 17 secrecy of the ballot, promote voter access, and ensure that all
- 18 legally cast ballots are counted.
- 19 SECTION 1.05. Section 1.003, Election Code, is amended by
- 20 adding Subsection (a-1) to read as follows:
- 21 <u>(a-1) Election officials and other public officials shall</u>
- 22 strictly construe the provisions of this code to effect the intent
- 23 of the legislature under Section 1.0015.
- SECTION 1.06. Section 1.018, Election Code, is amended to
- 25 read as follows:
- Sec. 1.018. APPLICABILITY OF PENAL CODE. In addition to
- 27 Section 1.03, Penal Code, and to other titles of the Penal Code that

- 1 may apply to this code, <u>Titles 2 and</u> [<u>Title</u>] 4, Penal Code, <u>apply</u>
- 2 [applies] to offenses prescribed by this code.
- 3 ARTICLE 2. REGISTRATION OF VOTERS
- 4 SECTION 2.01. Section 13.002, Election Code, is amended by
- 5 adding Subsection (c-1) to read as follows:
- 6 (c-1) The information required under Subsection (c) must be
- 7 supplied by the person desiring to register to vote.
- 8 SECTION 2.02. Section 15.021, Election Code, is amended by
- 9 amending Subsections (b) and (d) and adding Subsections (d-1) and
- 10 (d-2) to read as follows:
- 11 (b) Except as provided by Subsection (d), the [The] voter
- 12 shall use the registration certificate or a registration
- 13 application form as the notice, indicating the correct information
- 14 in the appropriate space on the certificate or application form
- 15 unless the voter does not have possession of the certificate or an
- 16 application form at the time of giving the notice.
- 17 (d) A voter [who continues to reside in the county in which
- 18 the voter is registered] may correct information under this section
- 19 by digital transmission of the information under a program
- 20 administered by the secretary of state and the Department of
- 21 Information Resources.
- 22 (d-1) If the notice indicates that a voter no longer resides
- 23 <u>in the county in which the voter is registered</u>, the registrar shall
- 24 forward the notice and the voter's original application for
- 25 registration to the registrar of the county in which the voter
- 26 resides. The registrars shall coordinate to ensure that the
- 27 voter's existing registration is canceled immediately after the

- 1 voter is registered in the county in which the voter resides in
- 2 accordance with Subsection (d-2).
- 3 (d-2) A registrar who receives a voter's notice and
- 4 application from another registrar under Subsection (d-1) shall
- 5 treat it as an original application for registration under Section
- 6 13.002, and shall register the voter if the voter resides in the
- 7 county and is otherwise eligible under Section 13.001.
- 8 SECTION 2.03. Section 15.028, Election Code, is amended to
- 9 read as follows:
- 10 Sec. 15.028. NOTICE OF UNLAWFUL VOTING OR REGISTRATION [TO
- 11  $\frac{PROSECUTOR}{(a)}$ ]. [(a)] If the registrar determines that a person who
- 12 is not eligible to vote either registered to vote or [a registered
- 13 voter] voted in an election, the registrar shall execute and
- 14 deliver to the attorney general, the secretary of state, and the
- 15 county or district attorney having jurisdiction in the territory
- 16 covered by the election an affidavit stating the relevant facts.
- 17 [(b) If the election covers territory in more than one
- 18 county, the registrar shall also deliver an affidavit to the
- 19 attorney general.
- 20 ARTICLE 3. CONDUCT AND SECURITY OF ELECTIONS
- 21 SECTION 3.01. Section 2.053(a), Election Code, is amended
- 22 to read as follows:
- 23 (a) On receipt of the certification, the governing body of
- 24 the political subdivision by order or ordinance shall [may] declare
- 25 each unopposed candidate elected to the office. If no election is to
- 26 be held on election day by the political subdivision, a copy of the
- 27 order or ordinance shall be posted on election day at each polling

- 1 place used or that would have been used in the election.
- 2 SECTION 3.02. Section 2.056(c), Election Code, is amended
- 3 to read as follows:
- 4 (c) A certifying authority shall [may] declare a candidate
- 5 elected to an office of the state or county government if, were the
- 6 election held, only the votes cast for that candidate in the
- 7 election for that office may be counted.
- 8 SECTION 3.03. Sections 43.007(c) and (d), Election Code,
- 9 are amended to read as follows:
- 10 (c) In conducting the program, the secretary of state shall
- 11 provide for an audit of the voting system equipment [direct
- 12 recording electronic voting units | before and after the election,
- 13 and during the election to the extent such an audit is practicable.
- 14 (d) The secretary of state shall select to participate in
- 15 the program each county that:
- 16 (1) has held a public hearing under Subsection (b);
- 17 (2) has submitted documentation listing the steps
- 18 taken to solicit input on participating in the program by
- 19 organizations or persons who represent the interests of voters;
- 20 (3) has implemented a computerized voter registration
- 21 list that allows an election officer at the polling place to verify
- 22 that a voter has not previously voted in the election;
- 23 (4) uses direct recording electronic voting machines,
- 24 ballot marking devices, or hand-marked scannable paper ballots that
- 25 are printed and scanned at the polling place or any other type of
- 26 voting system equipment that the secretary of state determines is
- 27 capable of processing votes for each type of ballot to be voted in

- 25 unless the territory covered by the election has fewer than 1,000
- 26 registered voters. In that case, the voting shall be conducted at
- 27 least four [three] hours each day. The authority ordering the

- 1 election, or the county clerk if that person is the early voting
- 2 clerk, shall determine which hours the voting is to be conducted.
- 3 (c) In a county with a population of  $55,000 \left[\frac{100,000}{1}\right]$  or
- 4 more, the voting in a primary election or the general election for
- 5 state and county officers shall be conducted at the main early
- 6 voting polling place for at least 12 hours on each weekday of the
- 7 last week of the early voting period, and the voting in a special
- 8 election ordered by the governor shall be conducted at the main
- 9 early voting polling place for at least 12 hours on each of the last
- 10 two days of the early voting period. <u>Voting under this subsection</u>
- 11 may not be conducted earlier than 6 a.m. or later than 10 p.m.
- 12 Voting shall be conducted in accordance with this subsection in
- 13 those elections in a county with a population under 55,000
- 14 [100,000] on receipt by the early voting clerk of a written request
- 15 for the extended hours submitted by at least 15 registered voters of
- 16 the county. The request must be submitted in time to enable
- 17 compliance with Section 85.067.
- 18 (d) A voter who has not voted before the scheduled time for
- 19 closing a polling place is entitled to vote after that time if the
- 20 voter is in line at the polling place by closing time. The secretary
- 21 of state shall promulgate any materials and provide any training to
- 22 presiding judges necessary to properly process voters under this
- 23 subsection [In an election ordered by a city, early voting by
- 24 personal appearance at the main early voting polling place shall be
- 25 conducted for at least 12 hours:
- 26 [(1) on one weekday, if the early voting period
- 27 consists of less than six weekdays; or

- 1 [(2) on two weekdays, if the early voting period
- 2 consists of six or more weekdays].
- 3 SECTION 3.09. Sections 85.006(b) and (e), Election Code,
- 4 are amended to read as follows:
- 5 (b) In an election in which a county clerk [or city
- 6 secretary] is the early voting clerk under Section 83.002 [or
- 7 83.005], only the early voting clerk may order voting on a Saturday
- 8 or Sunday. The clerk must do so by written order.
- 9 (e) In a primary election or the general election for state
- 10 and county officers in a county with a population of 55,000
- 11 [100,000] or more, the early voting clerk shall order voting by
- 12 personal appearance [voting] at the main early voting polling place
- 13 to be conducted on the last Saturday of the early voting period for
- 14 at least 12 hours, except that voting may not be conducted earlier
- 15 than 6 a.m. or later than 10 p.m., [on the last Saturday] and on the
- 16 <u>last Sunday of the early voting period</u> for at least <u>six</u> [<u>five</u>]
- 17 hours, except that voting may not be conducted earlier than 9 a.m.
- 18 or later than 10 p.m [on the last Sunday of the early voting
- 19 period]. The early voting clerk shall order voting to be conducted
- 20 at those times in those elections in a county with a population
- 21 under 55,000 [100,000] on receipt of a written request for those
- 22 hours submitted by at least 15 registered voters of the county. The
- 23 request must be submitted in time to enable compliance with Section
- 24 85.007. This subsection supersedes any provision of this subchapter
- 25 to the extent of any conflict.
- SECTION 3.10. Section 85.010(a-1), Election Code, is
- 27 amended to read as follows:

- 1 (a-1) In this section, "eligible county polling place"
- 2 means an early voting polling place[, other than a polling place
- 3 established under Section 85.062(e), established by a county.
- 4 SECTION 3.11. Section 85.061(a), Election Code, is amended
- 5 to read as follows:
- 6 (a) In a countywide election in which the county clerk is
- 7 the early voting clerk under Section 83.002, an early voting
- 8 polling place shall be located inside [at] each branch office that
- 9 is regularly maintained for conducting general clerical functions
- 10 of the county clerk, except as provided by Subsection (b). If a
- 11 suitable room is unavailable inside the branch office, the polling
- 12 place may be located in another room inside the same building as the
- 13 branch office.
- SECTION 3.12. Section 85.062, Election Code, is amended by
- 15 amending Subsection (b) and adding Subsection (f-1) to read as
- 16 follows:
- 17 (b) A polling place established under this section may be
- 18 located, subject to Subsection (d), at any place in the territory
- 19 served by the early voting clerk and may be located inside [in] any
- 20 <u>building</u> [stationary structure] as directed by the authority
- 21 establishing the branch office. The polling place may not be
- 22 located in a movable structure in the general election for state and
- 23 county officers, general primary election, or runoff primary
- 24 election. Ropes or other suitable objects may be used at the
- 25 polling place to ensure compliance with Section 62.004. Persons
- 26 who are not expressly permitted by law to be in a polling place
- 27 shall be excluded from the polling place to the extent practicable.

- 1 (f-1) Notwithstanding any other provision of this section
- 2 concerning the location of temporary branch polling places, in an
- 3 election in which countywide polling places are used, the
- 4 commissioners court of a county shall employ the same methodology
- 5 it uses to determine the location of countywide polling places to
- 6 determine the location of temporary branch polling places.
- 7 SECTION 3.13. Section 124.002, Election Code, is amended by
- 8 adding Subsection (c) to read as follows:
- 9 (c) Voting system ballots may not be arranged in a manner
- 10 that allows a political party's candidates to be selected in one
- 11 motion or gesture.
- 12 ARTICLE 4. ELECTION OFFICERS AND OBSERVERS
- SECTION 4.01. Section 32.075, Election Code, is amended by
- 14 adding Subsections (g) and (h) to read as follows:
- 15 (g) A presiding judge may not have a watcher duly accepted
- 16 for service under Subchapter A, Chapter 33, removed from the
- 17 polling place for violating a provision of this code, the Penal
- 18 Code, or any other provision of law relating to the conduct of
- 19 elections, unless the violation was observed by an election judge
- 20 or clerk after the watcher was previously warned that the watcher's
- 21 conduct violated the law.
- (h) Notwithstanding Subsection (g), a presiding judge may
- 23 call a law enforcement officer to request that a poll watcher be
- 24 removed if the poll watcher commits a breach of the peace or a
- 25 violation of law.
- SECTION 4.02. Subchapter A, Chapter 33, Election Code, is
- 27 amended by adding Section 33.0015 to read as follows:

- 1 Sec. 33.0015. CHAPTER PURPOSE AND WATCHER DUTY. 2 purpose of this chapter is to preserve the integrity of the ballot box in accordance with Section 4, Article VI, Texas Constitution, 3 by providing for the appointment of watchers. It is the intent of 4 the legislature that watchers duly accepted for service under this 5 chapter be allowed to observe and report on irregularities in the 6 7 conduct of any election, but may not interfere in the orderly conduct of an election. To effect that purpose, a watcher appointed 8 under this chapter shall observe without obstructing the conduct of 9 an election and call to the attention of an election officer any 10 observed or suspected irregularity or violation of law in the 11 12 conduct of the election.

SECTION 4.03. Section 33.051, Election Code, is amended by

- 19 (h) Before accepting a watcher, the officer presented with a
- watcher's certificate of appointment shall require the watcher to 20

- 24 SECTION 4.04. Section 33.056, Election Code, is amended by

- 7 not be denied free movement where election activity is occurring

- 10 election activity is entitled to sit or stand near enough to see and
- 11 hear the activity.
- 12 SECTION 4.05. Subchapter C, Chapter 33, Election Code, is
- 13 amended by adding Section 33.0605 to read as follows:
- 14 Sec. 33.0605. OBSERVING DATA STORAGE SEALING AND TRANSFER.
- 15 (a) A watcher appointed to serve at a polling place in an election
- 16 who is available at the time of the action may observe all election
- 17 activities relating to closing the polling place, including the
- 18 sealing and transfer of a memory card, flash drive, hard drive, data
- 19 storage device, or other medium now existing or later developed
- 20 used by the voting system equipment.
- 21 (b) Notwithstanding any other provision of this code, a
- 22 watcher duly accepted for service at a polling location is entitled
- 23 to follow the transfer of election materials from the polling place
- 24 at which the watcher was accepted to a regional tabulating center,
- 25 the central counting station, or any other location designated to
- 26 process election materials. The authority responsible for
- 27 administering a regional tabulating center or another location

- 1 where election materials are processed must accept duly appointed
- 2 watchers for service in the same manner a watcher is accepted for
- 3 service under Section 33.051 and must accept the same number of
- 4 watchers that may serve under Section 33.007(a).
- 5 SECTION 4.06. Section 33.061(a), Election Code, is amended
- 6 to read as follows:
- 7 (a) A person commits an offense if the person serves in an
- 8 official capacity at a location at which the presence of watchers is
- 9 authorized and knowingly prevents a watcher from observing an
- 10 activity or procedure the person knows the watcher is entitled to
- 11 observe, including by taking any action to obstruct the view of a
- 12 watcher or distance the watcher from the activity or procedure to be
- 13 <u>observed in a manner that would make observation not reasonably</u>
- 14 effective.
- 15 SECTION 4.07. Subchapter C, Chapter 33, Election Code, is
- 16 amended by adding Section 33.063 to read as follows:
- 17 Sec. 33.063. RELIEF. The appointing authority for a
- 18 watcher who believes that the watcher was unlawfully prevented or
- 19 obstructed from the performance of the watcher's duties may seek:
- 20 (1) injunctive relief under Section 273.081,
- 21 <u>including issuance of temporary orders;</u>
- 22 (2) a writ of mandamus under Section 161.009 or
- 23 273.061; and
- 24 (3) any other remedy available under law.
- 25 SECTION 4.08. Section 34.005, Election Code, is amended to
- 26 read as follows:
- Sec. 34.005. ACTION BY SECRETARY OF STATE. (a) The

- 18 envelope. The carrier envelope may be delivered in another
- 19 envelope and must be transported and delivered only by:
- 20 (1) mail;
- 21 (2) common or contract carrier; or
- 22 (3) subject to <u>Subsections</u> [<u>Subsection</u>] (a-1) <u>and</u>
- 23 (a-2), in-person delivery by the voter who voted the ballot.
- 24 (a-2) An in-person delivery of a marked ballot voted under
- 25 this chapter must be received by an election official at the time of
- 26 delivery. The receiving official shall record the voter's name,
- 27 signature, and type of identification provided under Section

- 1 63.0101 on a roster prescribed by the secretary of state. The
- 2 receiving official shall attest on the roster that the delivery
- 3 complies with this section.
- 4 SECTION 4.10. Section 129.023, Election Code, is amended by
- 5 adding Subsections (b-2) and (c-1) to read as follows:
- 6 (b-2) If the test is being conducted for an election in
- 7 which a county election board has been established under Section
- 8 <u>51.002</u>, the general custodian of election records shall notify each
- 9 member of the board of the test at least 48 hours before the date of

- ARTICLE 5. VOTING BY MAIL
- SECTION 5.01. Section 84.001(b), Election Code, is amended

- 19 (b) Subject to Section 1.011, an [An] application must be
- 20 submitted in writing and signed by the applicant using ink on paper.
- 21 An electronic signature or photocopied signature is not permitted.
- SECTION 5.02. Section 84.002, Election Code, as effective
- 23 September 1, 2021, is amended by amending Subsection (a) and adding
- 24 Subsection (d) to read as follows:
- 25 (a) An early voting ballot application must include:
- 26 (1) the applicant's name and the address at which the
- 27 applicant is registered to vote;

- 1 (1-a) the following information:
- 2 (A) the number of the applicant's driver's
- 3 license or personal identification card issued by the Department of
- 4 Public Safety;
- 5 (B) if the applicant has not been issued a number
- 6 described by Paragraph (A), the last four digits of the applicant's
- 7 social security number; or
- 8 (C) a statement by the applicant that the
- 9 applicant has not been issued a number described by Paragraph (A) or
- 10 (B);
- 11 (2) for an application for a ballot to be voted by mail
- 12 on the ground of absence from the county of residence, the address
- 13 outside the applicant's county of residence to which the ballot is
- 14 to be mailed;
- 15 (3) for an application for a ballot to be voted by mail
- 16 on the ground of age or disability, the address of the hospital,
- 17 nursing home or other long-term care facility, or retirement
- 18 center, or of a person related to the applicant within the second
- 19 degree by affinity or the third degree by consanguinity, as
- 20 determined under Chapter 573, Government Code, if the applicant is
- 21 living at that address and that address is different from the
- 22 address at which the applicant is registered to vote;
- 23 (4) for an application for a ballot to be voted by mail
- 24 on the ground of confinement in jail, the address of the jail or of a
- 25 person related to the applicant within the degree described by
