1 Plaintiffs Mi Familia Vota, Arizona Coalition for Change, Living United for Change
2 in Arizona, and League of Conservation Voters, Inc. d/b/a Chispa AZ (jointly, “Plaintiffs”),
3 Defendant Arizona Attorney General, and nominal Defendant the Arizona Secretary of
4 State herein provide an update on the status of negotiations concerning resolution of this
5 litigation short of trial.

6 As explained in the previous Joint Status Report, counsel for Plaintiffs and the named
7 Defendants had reached an agreement in principle for resolution of the litigation
8 conditioned on the approval of Arizona’s Voter Registration Advisory Committee
9 (“VRAC”). The VRAC has not approved the guidance that the proposed resolution
10 included. Plaintiffs will serve any expert disclosures by July 30, 2025, as required by the
11 Court’s scheduling orders.
