League of Women Voters, *et al.*, (“Petitioners”) do not oppose Senator Vernon Sykes and House Minority Leader Allison Russo’s motion to move the primary-election date—with one qualification: Petitioners respectfully request that any order by this Court moving the primary election date clearly indicates that the order only applies to the General Assembly elections. This limitation is consistent with the content of the motion at issue, which discusses the progress being made by the Commission only in connection with the General Assembly plan. *See* Resp’ts’ Sykes and Russo Mot. to Move The Primary Election Date, at 4, *League of Women Voters of Ohio v. Ohio Redistricting Comm.*, No. 2021-1193.
