The petitioner's motion to continue trial and to allow for a cross-motion for summary judgment is granted. Neither side (based on their statements at the hearing held on November 4, 2022) realistically believes that a trial will ultimately be necessary and that the disputed issues can more than likely be resolved through the summary judgment process. To the degree the petitioner believes that important data and factual information can be derived from the results of the 2022 general election being held today, it should be afforded the opportunity to marshall that information in order to provide a fully-developed record for those cross-motions.

Accordingly, the current trial date of January 17, 2023 will be continued. A trial setting conference will be held (as scheduled below) to obtain a new trial date, which shall be after July 1, 2023. The anticipated submission of the parties' cross-motions for summary judgment will be on the following schedule:

1. The parties shall have until February 1, 2023 in which to submit their cross-motions for summary judgment in final form, along with any supplemental supporting documentation or memoranda.

2. The parties shall have until March 1, 2023 in which to file their final resistances to the other's motion for summary judgment.

3. Any reply to a party's resistance shall be filed no later than March 15, 2023.

Hearing on the cross-motions for summary judgment shall be scheduled by separate order upon consultation with counsel to accommodate schedules.
