**EMERGENCY MOTION FOR TEMPORARY RESTRAINING ORDER TO BE HEARD
BY THREE- JUDGE COURT**

Marvis McDaniel Ivey hereby requests a temporary restraining Order pursuant to Rule 65(b) and shows the court as follows:

1.

Restating the Second Amended Complaint in the above matter by this reference as if specifically set out herein and made a part hereof with the following additions:

- (a) Marvis McDaniel Ivey timely filed for recount to be done by hand count with omission of any computer use until the count is completed due to malicious racist police interference into the first results.
- (b) Request has been denied due to race of plaintiff, Black and her adversaries Whites in the Dekalb County Police Department on behalf of Martinez, Badge 3103 and the fact that the recount will show elections crimes;
- (c) The case was maliciously closed in the Dekalb County Superior Court;
- (d) The State of Georgia, represented by Defendant Raffensperger has denied equal rights to recount under law.
- (e) Marvis McDaniel Ivey was congratulated at 04:00 A. M. on May 25, 2022 and the results were later changed.

Pursuant to Article I, Section II, Paragraph 9, "...all officers and employees of the state or its departments and agencies may be subject to suit and may be liable for injuries and damages caused by the negligent performance of, or negligent failure to perform, their ministerial functions and may be liable for injuries and damages if they act with actual malice or with actual intent to cause injury in the performance of their official functions..." Raffnsperger has willfully and intentionally negligently implemented the changes in the Redistricting of the above referenced State of Georgia Representatives House Districts 85 and 86. Marvis McDaniel Ivey has suffered irreparable damages.

Unless the General Election is postponed and the recount performed no later than Monday, November 7, 2022 to substantiate the postponement of the General Election through

the exposure of the elections fraud involving intentional criminal acts of elections officials in certifying results which they knew to be false having declared Marvis McDaniel Ivey the winner of the State Representative for House District 86 by 4:00 A.M.
