The New Mexico Office of the Secretary of State ("Secretary") was not directly involved in the 2021 redistricting process and the Secretary's statutory obligation to Senate Bill 1, 2021 Leg., 2nd Spec. Sess., 55th Leg. (N.M. 2021), is only to receive and chapter it. *See* Const. Art. IV, § 22. As such, the Secretary did not join or take a substantive position on the controlling legal issues presented by the Legislative and Executive Branch Defendants in their Motion to Dismiss pursuant to Rule 1-012(B)(1) and (6) NMRA 2021 in the underlying case. To the extent that the Secretary's position is sought for review by the Supreme Court, the Secretary will again take no substantive position on the ultimate questions presented in the jointly filed *Verified Petition for Writ of Superintending Control* ("Verified Petition").

This being said, the Secretary urges this Court to grant the Verified Petition

This being said, the Secretary urges this Court to grant the Verified Petition and Order a hearing and supplemental briefing on the issues presented, as a timely resolution of these essential legal questions are necessary, will bring clarity to the election administration, and preserve the elective franchise. Granting the Verified Petition will also avoid the parties incurring unnecessary litigation costs and conserves the judicial resources of the New Mexico courts.

CONCLUSION

The Secretary asks this Court to issue the Writ of Superintending Control and Order a hearing and supplemental briefing on the issues presented in the Verified Petition if the Court deems necessary.
