WHEREAS Defendant-Intervenor-Appellant Muhammad Shahidullah filed the above captioned appeal on July 25, 2022 from the decision and order entered in Richmond County Supreme Court on June 27, 2022 finding Local Law 11 unconstitutional.

WHEREAS counsel to Mr. Shahidullah filed a Notice of Motion to Amend Caption and Remove party on February 2, 2023 at the Richmond County Supreme Court seeking to remove Mr. Shahidullah as a party to this action on the grounds he is no longer eligible to vote under Local Law 11 as a naturalized citizen. On March 1, 2023, Hon. Ralph Porzio granted the Order to Amend Caption and Remove. (See Attached Exhibit A). It was ordered that the caption be amended and Muhammad Shahidullah, as Defendant-Intervenor, be removed as party to this case. The eight other named Defendant-Intervenor-Appellants will proceed with this appeal.

IT IS HEREBY STIPULATED AND AGREED pursuant to 22 NYCRR 1250.2(b)(2) that the portion of the appeal as related to Defendant-Intervenor-Appellant Muhammad Shahidullah is withdrawn.
