Lange General Counsel Office of the Secretary of State 325 Don Gaspar, Suite 300 Santa Fe, New Mexico 87501 dylan.lange@state.nm.us As stated in its *Response To the Verified Petition for Superintending Control* filed in this matter on September 6, 2022, the New Mexico Office of the Secretary of State ("Secretary") is only a nominal party in this matter and was not directly involved in the 2021 redistricting process. As such, the Secretary does not opine or take a substantive position on the controlling legal issues presented by the Legislative and Executive Branch Defendants in their Motion to Dismiss pursuant to Rule 1-012(B)(1) and (6) NMRA, in the underlying case. On October 14, 2022, this Court issued an Order directing all parties to file supplemental briefs. To the extent that the Secretary's position is sought for review by the Supreme Court, the Secretary will again take no substantive position on the ultimate questions presented in the jointly filed *Brief-In-Chief*.

This being said, the Secretary urges this Court to resolve this important legal dispute as quickly as possible as our office must provide nominating petitions to all prospective candidates by October of this year. *See* NMSA 1978, Section 1-8-30(D) (2011). In addition, having this issue resolved to ensure finality in the Federal Congressional Districts by October 2023, will guarantee both voters and candidates are prepared for the 2024 Primary Election.
