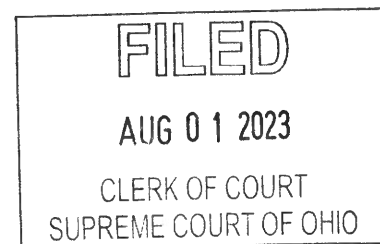

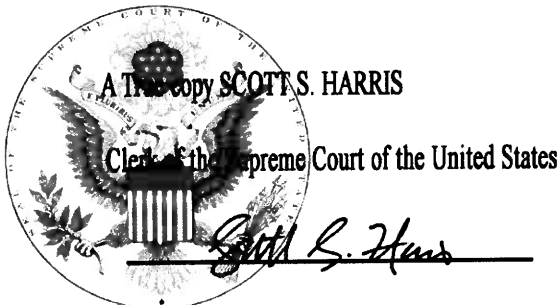
THIS CAUSE having been submitted on the petition for writ of certiorari


