6 3. Clark County will provide an observation area in the two signature verification
7 rooms that will accommodate at least five (5) observers absent any state or federal
8 emergency orders regarding social distancing.

9 4. This matter shall be dismissed without prejudice.

10 5. Each party shall be responsible for their own costs and fees.
