11 **ORDER SETTING HEARING**

12 Presently before the Court is *Plaintiffs' Ex Parte Application for a Temporary*
13 *Restraining Order to Conduct Meaningful Voter Observation in Washoe County,*
14 *Nevada on Order Shortening Time Pursuant to WDCR 11* (“the Application”) filed by
15 Plaintiffs ROBERT BEADLES ET AL (“Plaintiffs”) on April 28, 2022. This Court
16 accepted reassignment of this case on May 5, 2022. On May 11, 2022, Plaintiffs
17 submitted the Application to this Court for consideration.

18 The Court believes a hearing is necessary to resolve the Application. *See* WDCR
19 12(5). The hearing will be held **IN PERSON** in the Department 7 courtroom of the
20 Second Judicial District Court on **Wednesday, May 25, 2022, at 3:00 p.m.**

21 There is a hearing set on May 18, 2022, on a Motion to Intervene as Defendant
22 submitted to the Court by Proposed Intervenor-Defendant PROGRESSIVE
23 LEADERSHIP ALLIANCE OF NEVADA (“Proposed Intervenor-Defendant”). If the
24 Court grants the Motion to Intervene as Defendant, Proposed Intervenor-Defendants
25 have until May 23, 2022, by 5:00 p.m. to file an opposition to the Application.

26 If Defendants BARBARA CEGAVSKE and DEANNA SPIKULA (“Defendants”)
27 want to file responsive pleadings to the Application, their responses are also due on
28 May 23, 2022, by 5:00 p.m.

1 Furthermore, Plaintiffs are directed to personally serve copies of this Order on
2 all named defendants and potential intervenor-defendants. Plaintiffs must also
3 personally serve copies of the Complaint and the Application on all named defendants
4 and potential intervenor-defendants. Proof of service must be filed accordingly.

5 Accordingly, and good cause appearing, the *Plaintiffs' Ex Parte Application for a*
6 *Temporary Restraining Order to Conduct Meaningful Voter Observation in Washoe*
7 *County, Nevada on Order Shortening Time Pursuant to WDCR 11* is hereby **SET FOR**
8 **HEARING** on May 25, 2022, at 3:00 p.m. in person at the Department 7 courtroom.
