**ORDER DENYING MOTION TO EXPEDITE**

The court has considered appellants' motion to expedite, the responses, and the reply. Appellants, citing Arizona Rules of Civil Appellate Procedure 3(a) and 5(b) ask the court to order expedited briefing and oral argument to be completed by August 1, 2022, because the outcome of this appeal may require changes to the administration of the upcoming general election. In the alternative, appellants ask the court to accelerate the appeal pursuant to Arizona Rule of Civil Appellate Procedure 29. The parties have not stipulated to accelerate this appeal and the court will not accelerate an appeal based on a party's motion until it is at issue. ARCAP 29(b)(2).

IT IS ORDERED denying the motion without prejudice to any party filing a motion to accelerate after this appeal is at issue.
