Dear Mr. Krimmel:

I am writing in response to Mr. Fischer’s August 2, 2022 letter to you regarding the above-referenced matter.

As the Court is aware, the parties participated in a lengthy evidentiary hearing on Thursday, July 28, 2022 before the Honorable President Judge Renee Cohn Jubelirer. In Petitioners’ Petition for Review, Paragraph No. 23, as well as through the testimony of Deputy Secretary Marks, Petitioners represented to the Court that all but the Respondent Counties had included undated absentee and mail-in ballots in their certified election results. In addition, the representation was made to the Court that all of the county results had been certified by the Acting Secretary except for the results of the three Respondent Counties, including any elections encompassing the three Respondent Counties.

On Friday, July 29, 2022, I was informed by a Butler County official that Butler County did not include undated absentee and mail-in ballots in its certified election results by email dated Sunday, July 31, 2022. I notified counsel for Petitioners of the same. On Monday, August 1, 2022, I was provided a copy of Butler County’s letter to Deputy Secretary Marks informing him that Butler County did not include undated absentee mail-in ballots in its certified election results

(attached hereto). As the Court will recall, Deputy Secretary Marks testified that all of the county election results have been certified by the Acting Secretary except for the three Respondent Counties.

Further, I was informed by a Butler County official that there may be other counties beyond Butler County and the three Respondent Counties that did not include undated absentee and mail-in ballots in their respective certified election results. I have asked counsel for Petitioners to confirm whether all counties, excluding Respondent Counties and Butler County, have submitted certified election results which include undated absentee and mail-in ballots. Petitioners' representation via Mr. Fischer's August 2, 2022 letter that "the department has reviewed its records in respect to the remaining counties, and it is not aware of any other county that did not include undated ballots in the certified returns submitted to the Acting Secretary.", is inconsistent with its prior representations. Petitioners have previously made an affirmative representation that all but the three Respondent Counties have included undated absentee and mail-in ballots in their certified election results. Now, Petitioners are representing to the Court that they are unaware of any additional counties, which is materially different from their prior statements of fact.

Will you please provide this response to the Attorney General's letter, to the Court as well, if appropriate.

As Solicitor for the County of Butler, I have been directed to respond to your email correspondence, dated June 17, 2022, which was directed to the Butler County Elections Bureau.
