NOTICE OF APPEAL


Notice is hereby given that, pursuant to Pa.R.A.P. 1101, Petitioners Timothy R. Bonner, P. Michael Jones, David H. Zimmerman, Barry J. Jozwiak, Kathy L. Rapp, David Maloney, Barbara Gleim, Robert Brooks, Aaron Bernstine, Timothy F. Twardzik, Dawn W. Keefer, Dan Moul, Francis X. Ryan, and Donald “Bud” Cook appeal to the Supreme Court of Pennsylvania from the Commonwealth Court’s Order dated and entered on June 27, 2023.

In the June 27, 2023 Order, the Commonwealth Court (1) denied Petitioners’ Application for Summary Relief on their Petition for Review in the Nature of an Action for Declaratory Judgment (“Petition”), (2) granted the Cross-Applications for Summary Relief filed by Respondents, Leigh M. Chapman, in her official capacity as Acting Secretary of the Commonwealth of Pennsylvania, and the Commonwealth of Pennsylvania, Department of State, and Intervenor Respondents, the Democratic National Committee and Pennsylvania Democratic Party and the Democratic Senatorial Campaign Committee and Democratic Congressional Campaign Committee, (3) granted the Application for Summary Relief filed by Respondents and Intervenor Respondents and dismissed Rancis X. Ryan as a party for lack of standing, and (4) dismissed as moot the preliminary objections filed by the Respondents and Intervenor Respondents.

The June 27, 2023, Order of the Commonwealth Court is attached hereto as Exhibit A, and the Order has been officially entered on the docket as evidenced by the copy of the docket entries for this action, which is attached hereto as Exhibit B. Notably, there is no verbatim record of the proceedings relating to Petitioners' and Respondents' cross-applications for summary relief. Petitioners are filing and serving upon the parties their Jurisdictional Statement concurrently with this Notice of Appeal.
