DEFENDANTS' UNOPPOSED
MOTION FOR EXTENSION OF
TIME TO RESPOND TO
PLAINTIFFS' FIRST AMENDED
COMPLAINT

1 Defendant Mark Brnovich, in his official capacity as Attorney General for the State
2 of Arizona (the “AG”), and Intervenor-Defendant Yuma County Republican Committee
3 (the “YCRC”) respectfully request an extension on behalf of all defendants to respond to
4 Plaintiffs’ First Amended Complaint (Doc. 20)(“FAC”) to November 18th.

5 Plaintiffs and the AG had previously agreed to extend the deadline to respond to
6 sixty days after the service of the FAC and have further stipulated to extend all defendants’
7 deadline to respond to November 18. The parties have further agreed that in the event one
8 or more of the defendants file a motion to dismiss, Plaintiffs’ response to said motion would
9 be extended to December 23rd, and any reply to January 13th. Plaintiffs do not oppose
10 this request.

11 **WHEREFORE**, the AG and YCRC respectfully request this Court enter an order
12 setting the briefing schedule as follows:

16 respond to Plaintiffs’ First Amended Complaint (“FAC”) on or before

 - 18 - Plaintiffs shall respond to any motions to dismiss, if one is filed in response to
19 the FAC, on or before **December 23, 2022;**
 - 20 - Replies to any response to a motion to dismiss, if one is filed, shall be made on
21 or before **January 13, 2022.**
