Kormanik v. Court of Appeals, L.C. #2022CV1395

A petition for supervisory writ pursuant to Wis. Stat. §§ (Rules) 809.71 and 809.51 and a motion for a temporary stay of proceedings in the court of appeals in Case Nos. 2022AP1720-LV and 2022AP1727-LV having been filed on behalf of petitioner, Nancy Kormanik, and considered by this court;

IT IS ORDERED that by 12:00 p.m. on October 13, 2022, the respondent, Court of Appeals, and all other parties in Case Nos. 2022AP1720-LV and 2022AP1727-LV shall file with the clerk of this court one or more responses to the petition. Each response shall be filed as an attachment in pdf format to an email addressed to clerk@wicourts.gov. See Wis. Stat. §§ 809.14, 809.80, and 809.81; and

IT IS FURTHER ORDERED that the motion for a temporary stay of proceedings in the court of appeals in Case Nos. 2022AP1720-LV and 2022AP1727-LV is granted in part and denied in part. The October 12, 2022 deadline for parties to file responses to the petition for leave to file an interlocutory appeal and to the motion for a stay of the circuit court's temporary injunction in Waukesha Case No. 2022CV1395 shall remain in effect. The court of appeals shall not take further action in Case Nos. 2022AP1720-LV and 2022AP1727-LV until further order of this court. The motion for a temporary stay in this writ proceeding does not ask this court to take any action regarding the temporary stay issued by the court of appeals in Case Nos. 2022AP1720-LV and 2022AP1727-LV, and therefore that temporary stay of the circuit court's temporary injunction shall remain in effect pending this court's resolution of the petition for supervisory writ.
