Before Brash, C.J.

Late this afternoon the Democratic National Committee filed a petition for leave to appeal and request for stay of a temporary injunction. The document was docketed in District II, but it appears that the petitioner seeks to have the matter heard in District IV, potentially pursuant to WIS. STAT. § 752.21(2). This court requires input from the parties as to the proper district to hear the petition and request for stay. Due to the urgent nature of this matter, this court directs the parties to electronically file simultaneous letter memoranda by 8:30 a.m. on Monday, October 10, 2022. The memoranda should address whether this matter is subject to WIS. STAT.

§ 752.21(2). This court will review on Monday, October 10, 2022, all filings that were made after 5 p.m. today with respect to this circuit court case.

In addition, the parties are directed to opt in to the electronic filing system for this case as soon as possible so that they are able to view filings from other parties after they are docketed on October 10, 2022. IT IS ORDERED that the parties shall electronically file letter memoranda as directed in this order by 8:30 a.m. on Monday, October 10, 2022.
