Rules 8-501, 8-502, 20-403, 20-404, and 20-406, with the exception that paper copies are not required to be filed; appellant's brief and appellee's brief to be filed on or before Tuesday, October 4, 2022, at 5:00 p.m.; any reply brief by either party to be filed on or before Thursday, October 6, 2022, at 12:00 p.m.; and it is further

**ORDERED**, that this case shall be set for argument during the October session of Court, with argument scheduled for Friday, October 7, 2022, at 10:00 a.m.
