**STIPULATED ORDER**

1. This Stipulated Order (“Order”) is entered into by and between Plaintiff Public Interest Legal Foundation, Inc., and Executive Director Monica Holman Evans (collectively, “the Parties”).

**BACKGROUND**

2. On June 24, 2021, Plaintiff requested the following two categories of records (together, the “Requested Records”) from Defendant pursuant to Section 8(i)(1) of the National Voter Registration Act of 1993 (“NVRA”), 52 U.S.C. § 20507(i)(1)<sup>1</sup> (the “Request”):

<sup>1</sup> NVRA Section 8(i)(1) provides, “Each State shall maintain for at least 2 years and shall make available for public inspection and, where available, photocopying at a reasonable cost, all records concerning the implementation of programs and activities conducted for the purpose of ensuring the accuracy and currency of official lists of eligible voters, except to the extent that such records relate to a declination to register to vote or to the identity of a voter registration agency through which any particular voter is registered.”

- a. All “ERIC Data” received from ERIC<sup>2</sup> during the years 2019, 2020, and 2021 concerning registered voters identified as deceased or potentially deceased (“ERIC Reports”).
  - b. All reports and/or statewide-voter-registration-system-generated lists showing all registrants removed from the list of eligible voters for reason of death for the years 2019, 2020, and 2021 (“Deceased Cancellation Reports”).
3. Defendant denied the Request for the ERIC Reports.
  4. Defendant granted in part and denied in part the Request as it related to the second category of records, providing a list of former registrants removed from the District of Columbia’s voter roll for the reason of death during the period January 1, 2019 – June 29, 2021, but withholding voter identification numbers and dates of birth on the grounds that D.C. law (3 D.C.M.R. § 510.5) prohibits disclosure of that information.
  5. On December 6, 2021, Plaintiff filed this action against Defendant (the “Litigation”).
  6. Defendant denies liability for the cause of action Plaintiff asserts in the Litigation.
  7. The Parties have negotiated in good faith and now jointly execute and submit this Order to resolve the Litigation.

## **JURISDICTION**

8. This Court has jurisdiction over this matter, pursuant to 28 U.S.C. § 1331 and 52 U.S.C. § 20510.

## **APPLICABILITY**

9. The terms of this Order shall apply to the Parties and their respective successors and assigns.

## **TERMS AND CONDITIONS**

### ***General Terms and Conditions***

10. The Parties to this Order are Plaintiff and Defendant. Except as to the release provision in Paragraph 22 below, nothing in this Order shall be construed to make any other person or entity not executing this Order a third-party beneficiary to this Order.

11. Each undersigned representative of the Parties to this Order certifies that he or she is fully authorized by the party to enter into and execute the terms and conditions of this Order and to legally bind such party to this Order.

12. This Order is the entire agreement between the Parties.

13. This Order may be executed in any number of counterpart originals, each of which shall be deemed to constitute an original agreement, and all of which shall constitute one agreement. The execution of one counterpart by any party shall have the same force and effect as if that party had signed all other counterparts.

14. This Order is governed by, and interpreted according to, the laws of the District of Columbia without regard to conflict of laws principles.

15. The Parties represent that prior to signing this Order, each has read it, understood its terms and conditions, consulted with counsel, and voluntarily signed it.

16. “ERIC Report Key” means the document attached hereto as Exhibit A.

***Terms Governing Production of Records***

**17. ERIC Reports**

- a. Defendant shall provide to Plaintiff the 2021 ERIC Reports, which shall include all data described in columns 1 through 49 of the ERIC Report Key.
- b. Defendant may redact the voter identification number in columns 11 and 12, only if the voter identification number reveals the source of registration.
- c. Defendant shall redact the data from the Social Security Administration in columns 50 through 58 of the ERIC Report Key.
- d. Plaintiff shall forgo and dismiss its claim for date of birth information with respect to the Requested Records.

***Terms Governing Time for Production and Future Requests***

18. Defendant shall provide the ERIC Reports described above to Plaintiff within forty-five (45) days of the date this Order is issued by the Court.

19. In the event Plaintiff requests ERIC Reports or Deceased Cancellation Reports from Defendant in the future pursuant to NVRA Section 8(i), Defendant shall provide the records to Plaintiff in accordance with the terms of this Order and as described below, unless Defendant determines that the law governing disclosure has changed. For future requests and absent Defendant’s determination that the law governing disclosure has changed, Defendant will disclose an ERIC Report in the following way:

- a. For ERIC Reports for which three calendar years have passed since the latest date of death noted in the report, Defendant shall produce the ERIC Report with no redactions, except to the extent necessary to protect the source of registration.
- b. Otherwise, Defendant will disclose the requested ERIC Report in the same manner as the 2021 ERIC Reports noted above.

#### **ATTORNEY'S FEES, COSTS, AND EXPENSES**

20. Within sixty (60) days of the date this Order is entered by the Court, Defendant shall pay to Plaintiff twenty-thousand dollars (\$20,000) as compensation for the attorney's fees, costs, and expenses the Plaintiff incurred in the prosecution of the Litigation. *See* 52 U.S.C. 20510(c).

#### **RETENTION OF JURISDICTION**

21. This Court retains jurisdiction to enforce the disclosure of the 2021 ERIC Reports under the terms of this Order.

#### **RELEASE AND DISMISSAL**

22. Upon entering this Order, the Plaintiff shall release Defendant, and her respective successors and assigns and any other District of Columbia agencies or officials, from any claims arising from the conduct related to the Litigation.

23. This Order constitutes a full settlement of and shall resolve all claims made by Plaintiff against Defendant in this Litigation. Upon entry of this Order, the Parties agree that this action shall be dismissed. Plaintiff shall file a joint stipulation of dismissal under

Fed. R. Civ. P. 41(a)(1)(A)(ii) within fourteen (14) days of Defendant producing the 2021 ERIC Reports to Plaintiff under the terms of this Order.
