
RULE TO SHOW CAUSE AND SCHEDULING ORDER

AND NOW, this ^{12th} day of September 2022, upon consideration of The Pennsylvania Alliance for
Retired Americans' Petition for Leave to Intervene filed on September 9, 2022,

IT IS ORDERED that:

1. A Rule is issued upon Petitioners Sean Gill, Robert Smith, Tim Ramos, Jackie Rivera and Respondents Lehigh County Board of Elections, Phillips Armstrong, Jennifer Allen, Dennis Nemes, Timothy A. Benyo, Diane Gordian to show cause why putative Intervenor is not entitled to the relief requested;
2. Petitioners and Respondents shall file an Answer to the Petition within twenty (20) days of service upon Respondents;
3. A hearing shall be held on the Petition to Intervene on **October 7, 2022 at 9:30 a.m. in Courtroom 5C** of the Lehigh County Courthouse, 455 W. Hamilton St. Allentown, Pennsylvania 18101;
4. Notice of the entry of this Order shall be provided to all parties by the putative Intervenor;

If said Petition to Intervene is unopposed by Petitioners and Respondents, a stipulation to that effect shall be filed no later than ten (10) days prior to the scheduled hearing, and the October 7, 2022, hearing shall proceed on the merits of the pending petition for preliminary injunction at which all parties shall present any evidence and argument in support of their respective positions.
