**PLAINTIFF'S MOTION FOR A PRELIMINARY INJUNCTION**

Pursuant to Federal Rule of Civil Procedure 65, Plaintiff CASA moves for a preliminary injunction requiring Defendants Julie Wheeler, Doug Hoke, and Ron Smith in their official capacities as the York County Board of Elections to comply with Section 4(e) of the federal Voting Rights Act, 52 U.S.C. § 10303(e), by making Spanish-language sample ballots and other election materials and Spanish-bilingual election officials available in York County, Pennsylvania.

Plaintiff's requested relief is set forth in the proposed order accompanying this motion. In summary, Plaintiff seeks an order preliminarily enjoining Defendants to take all measures necessary to ensure that all election materials in York County—including but not limited to sample ballots, voting guides, voting instructions, polling place signage, election-related websites and social media

handles, and registration materials—are provided in Spanish as well as English and to undertake additional recruitment efforts to hire bilingual poll workers to provide assistance at polling places for the November 8, 2022 general election. To enable effective relief before the November election, Plaintiff respectfully requests that the Court consider and resolve this motion as soon as possible. In order to assist the Court in resolving this important issue, pursuant to Local Rule 7.9, Plaintiff respectfully requests oral argument.

Plaintiff's motion is based on this motion, the attached memorandum, the accompanying proposed order, and the attached declarations of Plaintiff CASA and Julia Chapman.
