AND ORDER**



pursuant to § 9-209(2); following the cure procedures established by § 9-209(3); and scanning
absentee ballots into the counting machine tomorrow, October 28, as required by § 9-209(6); and

STIPULATED AND AGREED that Petitioners shall voluntarily dismiss this action
because Respondents have agreed to comply with the law, **without prejudice to any further
ruling to any superior court to the contrary**, providing Petitioners with the remedy sought in
their Petition.

ORDERED that this action is hereby dismissed without prejudice.
