**VERIFIED COMPLAINT FOR WRIT OF MANDAMUS
AND MOTION TO SHOW CAUSE AND TO EXPEDITE UNDER MCR 3.305(C)**

NOW COMES Plaintiffs Michigan Republican Party and Republican National Committee (collectively, "Plaintiffs"), who state the following as their Complaint against the Defendants, Davina Donahue, Interim City Clerk, in her official capacity as a member of City of Flint Board of Election Commissioners, William Kim, City Attorney, in his official capacity as a member of City of Flint Board of Election Commissioners, and Stacey Kaake, City Assessor, in her official capacity as a member of City of Flint Board of Election Commissioners:

INTRODUCTION

1. Plaintiffs seek an expedited hearing on this matter under MCR 2.605(D), which authorizes this Court to "order a speedy hearing of an action for declaratory relief" and to "advance [this case] on the calendar." Expedited consideration is warranted and necessary here. Absent declaratory relief, Plaintiffs' statutory right under Michigan law to have an "equal number, as nearly as possible," of Republican-affiliated election inspectors as Democrat-affiliated election inspectors at the upcoming general election in the City of Flint will continue to be violated and jeopardized by Defendants' acts.

2. Plaintiffs respectfully seek an ex parte order to show cause and to expedite consideration of these proceedings under MCR 3.305(C), which provides that in actions for mandamus, "[o]n ex parte motion and a showing of the necessity for immediate action, the court may issue an order to show cause. The motion may be made in the complaint. The court shall indicate in the order when the defendant must answer the order."

3. Immediate action is necessary under MCR 3.305(C). Under the default timeline in MCR 2.108(A)(1), the Defendants would have 21 days to file an answer, which would be Friday, November 18, 2022 – 10 days after the general election on Tuesday, November 8, 2022. Moreover, any oral argument would require additional time, which would leave no time to compel Defendants’ to comply with their clear legal duties under Michigan law. The default timeline for responsive pleadings under the Michigan rules would therefore directly injure Plaintiffs and prevent relief. To compel Defendants to act before November 8, 2022, Plaintiffs ask the Court to direct the Defendants to file their answer to a show cause order by 12:00 p.m. on Tuesday, November 1, 2022. Additionally, Plaintiffs respectfully request that the Court issue a decision on this request for relief by Wednesday, November 2, 2022. A proposed order granting the motion to show cause is attached hereto as **Exhibit E**.

4. Plaintiffs will make best efforts to effectuate formal service of process immediately upon the filing of this Verified Complaint and receipt of summonses from this Court, and will contact Defendant Kim, the City’s attorney, to ensure that he is aware of this filing and of Plaintiffs’ requests.

5. There remains time for this Court to issue the relief sought herein, and for Defendants to comply with a Court order compelling the satisfaction of their duties under the law. Indeed, Defendants have represented that they intend to continue holding election inspector training into November, which of course is consistent with the ongoing legal duties as set forth further below.

PARTIES, JURISDICTION, AND VENUE

6. Plaintiff the Michigan Republican Party (“MRP”) is a “major political party” as that term is defined by the Michigan Election Law. See MCL 168.16. Formed for the general

purposes of, among other things, ensuring that elections are conducted in an open, fair, and orderly manner, and that its rights and privileges and those of its members in connection with elections are exercised and are otherwise not violated or infringed upon. MRP maintains headquarters at 520 Seymour Street, Lansing, Michigan 48912.

7. Plaintiff the Republican National Committee (the “RNC”) is a national political party with its principal place of business at 310 First Street, S.E., Washington D.C., 20003. In addition to managing the Republican Party’s business affairs at the national level, the RNC supports state Republican parties (including MRP) by, among other actions, coordinating election strategy—including by supporting MRP’s efforts to appoint and support election inspectors to ensure that elections are conducted in an open, fair, and orderly manner.

8. Defendant Davina Donahue, Interim City Clerk, is a member of City of Flint Board of Election Commissioners. The City of Flint Board of Election Commissioners is responsible for overseeing the conduct of elections within the City of Flint. She is being sued in her official capacity as a city election official. Her official business address is 1101 S. Saginaw St., 2nd Floor City Hall, 201-C Flint, MI 48502.

9. Defendant William Kim, City Attorney, is a member of City of Flint Board of Election Commissioners. The City of Flint Board of Election Commissioners is responsible for overseeing the conduct of elections within the City of Flint. He is being sued in his official capacity as a city election official. His official business address is 1101 S. Saginaw St., 3rd Floor of Flint City Hall, Flint, MI 48502.

10. Defendant Stacey Kaake, City Assessor, is a member of City of Flint Board of Election Commissioners. The City of Flint Board of Election Commissioners is responsible for overseeing the conduct of elections within the City of Flint. She is being sued in her official

capacity as a city election official. Her official business address is 1101 S. Saginaw St, #201A Flint, MI 48502.

11. The 7th Judicial Circuit Court has jurisdiction over this Complaint, and venue in this Court is proper, because the Defendants are all residents, or maintain their principal places of business, in Genesee County, Michigan, and because all or part of the claim for relief at issue in this litigation arose in Genesee County, Michigan.

12. Plaintiffs are “litigant[s] [who have] a special injury or right, [and] substantial interest, that will be detrimentally affected in a manner different from the citizenry at large” and have standing to bring the claims asserted in this Complaint. *Lansing Sch Educ Ass'n v Lansing Bd of Educ*, 487 Mich 349, 372; 792 NW 2d 686 (2010).

13. Plaintiffs have been diligent in their efforts to vindicate their legal rights and secure Defendants’ compliance with the legal duties under Michigan law. Plaintiffs have not been dilatory nor otherwise prejudiced Defendants with any undue delay attendant to the filing of this action.

COUNT I: WRIT OF MANDAMUS RE: DEFENDANTS’ DUTIES UNDER MCL 168.674(2) FOR EACH ELECTION PRECINCT.

14. Plaintiffs incorporate the allegations of the foregoing paragraphs as if fully stated herein.

15. Michigan law expressly requires that the City of Flint Board of Election Commissioners (the “Board”) “shall appoint an equal number, as nearly as possible, of election inspectors in each election precinct from each major political party.” MCL 168.674(2). The Board’s legal duty to appoint an equal number of election inspectors from each major political party to each election precinct runs through Election Day.¹ See MCL 168.674(5).

¹ While Michigan law permits the county chair of a major political party to challenge the appointment of *individual* election inspectors based on those individuals’ partisan bona fides,

16. Election inspectors play an important role in instilling confidence in our electoral process. While there may have been a shortage of Republican election inspectors in Flint during previous election cycles, this year Plaintiffs made a concerted effort to work with the City of Flint to assist in recruiting inspectors and to collaboratively assist the City in fulfilling its obligations under MCL 168.674.

17. On May 12, 2022, Plaintiffs provided former-Clerk Brown with applications for 122 Republicans interested in serving as election inspectors in the City of Flint for the August 2, 2022 primary election.

18. Despite Plaintiffs' efforts to assist the Defendants with satisfying Defendants' duties to appoint an equal number of election inspectors from each major political party, on July 16, 2022, the City of Flint provided the Genesee County Republican Party with a list indicating that the City had hired only 27 Republican election inspectors. The City had, however, hired 442 Democrat election inspectors for the same election. A 27:442 ratio does not satisfy the "equal as possible" requirement set forth under Michigan law. Therefore, the Board has failed to satisfy its clear legal duty to appoint an equal number of election inspectors from each major political party to each election precinct and each absent voter counting board ("AVCB") under MCL 168.674(2).

19. Because of the discrepancy between the quantity of Democrat and Republican election inspectors, the Plaintiffs contacted former-Clerk Brown on July 26, 2022—one week prior to the primary election—to address the City's unequal appointment of partisan election inspectors.

among other qualifications, see MCL 168.674(3), the Board's clear legal duty to appoint an equal number of election inspectors from each major political party to each election precinct and AVCB is enforceable through, among other actions, a writ of mandamus commenced by an aggrieved major political party such as Plaintiffs.

20. Former-Clerk Brown assured Plaintiffs that the City would contact the individual Republicans provided by Plaintiffs back in May 2022.

21. Soon after the primary election, Plaintiffs contacted the 122 Republicans on the list that Plaintiffs had provided former-Clerk Brown and learned that the City had hired only an additional 22 applicants.

22. The ratio of Democratic election inspectors to Republican election inspectors employed by the City of Flint for the August 2022 primary election was approximately 15:1. Again, this demonstrates that the Board has failed to satisfy its clear legal duty to appoint an equal number of election inspectors from each major political party to each election precinct and each absent voter counting board ("AVCB") under MCL 168.674(2).

23. Plaintiffs issued a letter to former-Clerk Brown on September 9, 2022, which enclosed a list of 61 Republicans that had confirmed their interest and availability to work as election inspectors during the November 2022 general election in the City of Flint. That letter also requested, as a show of good faith, written assurance that the clerk would commit to contacting and scheduling election inspector training for each person on that list. Plaintiffs, however, never received such written assurance.

24. Neither the 15:1 ratio for the August primary election nor the Board's subsequent effort to appoint an equal number as possible of Democrat and Republican election inspectors satisfied the Board's clear legal duties under Michigan law.

25. On October 15, 2022, Plaintiffs received the list of election inspectors issued by the Board to the Chair of the Genesee County Republican Party for the upcoming November 2022 general election. A copy of that correspondence and list are attached hereto as **Exhibit 1**.

26. Of the approximately 562 election inspectors included in the list, only 57—or approximately 10%—are Republicans. This disparity shows that the Board has failed to comply with its clear legal duty under MCL 168.674(2).

27. Since the August primary, additional Republicans have contacted the City Clerk's office to inquire about working as election inspectors. Yet, despite the disparity of Democratic election inspectors to Republican election inspectors appointed by the City, those Republican individuals were rejected by staff in the clerk's office.

28. In one instance, Ms. Gloria Boone, the City of Flint's Election Supervisor, informed a prospective Republican election inspector that the clerk's office had received "a lot" of calls from Republicans asking about serving as election inspectors. Ms. Boone expressly dismissed the notion that the City "needs more Republicans" as election inspectors because Flint "is a predominately Democratic area." Ms. Boone also indicated that a prospective election inspector's partisan affiliation is irrelevant to their serving as election inspectors. This, despite the Board's clear legal duty to appoint an equal number of election inspectors from each major political party to each election precinct and each AVCB.

29. In a good-faith attempt to resolve this matter without litigation, Plaintiffs (through counsel) sent to Defendants a letter dated October 21, 2022, requesting that the Board comply with its clear legal duties under MCL 168.674(2). (See Exhibit 2, October 21, 2022 Letter.) Defendant Kim responded to Plaintiffs' letter and acknowledged that Michigan law requires that the Board "shall appoint an equal number, as nearly as possible, of election inspectors in each election precinct from each major political party." MCL 168.674(2). (See Exhibit 3, October 25, 2022 Response Letter.)

30. Defendant Kim's response letter detailed the Board's purported efforts to appoint Republican-affiliated election inspectors, and represented that (a) recent appointments of City election inspectors have brought the total number of Republican-affiliated election inspectors to over 120, with "almost 50 of the persons listed" in Plaintiffs' October 21, 2022 letter having been appointed as election inspectors and (b) the City Clerk's office intended to contact persons identified on the list provided by Plaintiffs and inquire as to whether such persons remain interested in submitting the required application, attending the necessary training, and working the November 8 general election. (See Exhibit 3, October 25, 2022 Response Letter.)

31. Plaintiffs' unaddressed demands relating to the Board's violation of MCL 168.674(2) include, among other requests:

- a. Assist each prospective Republican election inspector that contacts the City to inquire about serving in that role in a manner consistent with this Board's ongoing duty under MCL 168.674(5), rather than turning those individuals away;
- b. Take affirmative actions to recruit additional Republican election inspectors, including but not limited to educating City staff about the requirement to recruit and appoint Republican election inspectors, and publicly posting a call for Republicans to volunteer to serve as election inspectors; and
- c. Assist each prospective Republican election inspector that contacts the City to inquire about serving in that role in a manner consistent with this Board's ongoing duty under MCL 168.674(5), rather than turning those individuals away.

32. Defendants' half-hearted steps do not satisfy their duties under MCL 168.674(2) or MCL 168.674(5).

33. Even if Plaintiffs take Defendant Kim's numbers to be true and adjust up accordingly from the numbers Plaintiffs had previously ascertained: now, of the approximately 682 election inspectors the city has, only 120—or approximately 17.6%—are Republicans. Defendants have not satisfied their ongoing duties under MCL 168.674(2) and (5) because, despite the numbers of partisan inspectors not yet being equal, and with the election still more than a week away, Defendants have refused to take the additional steps necessary to satisfy their clear legal duties through Election Day.

34. Defendant Kim accommodated this request on October 27, 2022. While the Board's hiring of additional Republican-affiliated election inspectors is a step in the right direction, it nevertheless falls woefully short of the Board's continuing duties under Michigan law.

35. Plaintiffs are entitled to a writ of mandamus: (a) Plaintiffs, as a major political party, have a clear legal right to the performance of the Board's duty to legal duty to appoint an equal number of election inspectors from each major political party under MCL 168.674(2) and (5); (b) the Defendants have a clear legal duty to perform those acts under MCL 168.674(2) and (5); (c) those acts of appointing election inspections are, by their very nature, ministerial; and (d) no other adequate legal or equitable remedy exists to achieve the relief sought. Indeed, while MCL 168.674 sets forth a separate, administrative process through which county chairs of political parties may challenge the partisan bona fides and qualifications of individual inspectors, that process does not provide a means for challenging the Board's failure to appoint as equal a number of partisan inspectors as possibly, and therefore that process does not provide Plaintiffs with a remedy here.

36. Without immediate action by this Court compelling Defendants to hire Republican-affiliated election inspectors, Plaintiffs' right to have "an equal number, as nearly as possible, of [Republican-affiliated] election inspectors in each election precinct" will forever be lost. MCL 168.674(2), (5).

COUNT II: WRIT OF MANDAMUS RE: DEFENDANTS' DUTIES UNDER MCL 168.674(2), (5), AND MCL 168.765a(2) REGARDING FLINT'S AVCB(S).

37. Plaintiffs incorporate the allegations of the foregoing paragraphs as if fully stated herein.

38. The Board's legal duty to appoint an equal number of election inspectors from each major political party also applies with equal force to Flint's AVCBs. See MCL 168.765a(2) (providing that the requirements for the appointment of equal numbers of election inspectors from each major political party, among other requirements under section 674, "apply to the appointment of election inspectors to [AVCBs.]").

39. The Board's legal duty to appoint an equal number of election inspectors from each major political party to each AVCB runs through Election Day. MCL 168.674(5).

40. As of October 21, 2022, Plaintiffs understood that the City of Flint had hired only four Republican election inspectors to work at its AVCBs, compared to the 56 Democrats hired by the City for the same role.

41. On October 26, 2022, Plaintiffs, through counsel, requested a telephone conference with Defendant Kim to discuss the City's non-compliance with the equal number requirement for AVCBs. Specific discussion points were to include:

- a. Requested reallocation of no fewer than 20 Republican election inspectors from precinct polling places to the City's AVCBs; and

- b. Appointment of no fewer than 25 Republican election inspectors as chairpersons.

42. Defendant Kim responded via email to Plaintiffs' counsel and declined to meet and confer regarding Plaintiff's requests, stating: "we find no clear legal duty to act as requested and would not want to create the appearance of showing undue favoritism to any political party."

43. Defendant Kim provided Plaintiffs' counsel a list of Republican-affiliated election inspectors, which list was purported to be current as of approximately 4:30 PM ET on October 27, 2022. The figures shown on that list, even assuming their veracity, continue to show that the Board has failed to satisfy its clear legal duties under MCL 168.674(2), (5), and MCL 168.765a(2).

44. These figures indicate that the total number of Republican-affiliated election inspectors is 130, with only six of these Republican-affiliated election inspectors having been assigned to Flint's AVCB. (See Exhibit 4.)

45. Therefore, the ratio of Republican election inspectors to Democrat election inspectors appointed to Flint's AVCBs is still far from equal, given that, to the best of Plaintiffs' knowledge, Flint has appointed only six Republicans to serve as election inspectors in its AVCBs in comparison to appointing 56 Democrats for that same role. That approximate 1:9 ratio is far from what is required of the Board by their ongoing duties under MCL 168.674(2), (5), and MCL 168.765a(2).

46. Defendant Kim's indication that the Board will not appoint additional Republican inspectors demonstrates that Defendants have no intention of satisfying their legal duties as to AVCBs under MCL 168.674(2) and (5).

47. Plaintiffs are entitled to a writ of mandamus: (a) Plaintiffs, as a major political party, have a clear legal right to the performance of the Board's duty to legal duty to appoint an

equal number of election inspectors from each major political party to each AVCB under MCL 168.674(2) and (5); (b) the Defendants have a clear legal duty to perform those acts under MCL 168.674(2) and (5); (c) those acts of appointing election inspections are, by their very nature, ministerial; and (d) no other adequate legal or equitable remedy exists to achieve the relief sought. Indeed, while MCL 168.674 sets forth a separate, administrative process through which county chairs of political parties may challenge the partisan bona fides and qualifications of individual inspectors, that process does not provide a means for challenging the Board's failure to appoint as equal a number of partisan inspectors as possibly, and therefore that process does not provide Plaintiffs with a remedy here.

48. Without immediate action by this Court compelling Defendants to reallocate Republican-affiliated election inspectors to AVCBs, Plaintiffs' right to have "an equal number, as nearly as possible, of [Republican-affiliated] election inspectors in each election precinct" will forever be lost. MCL 168.674(2), (5), MCL 168.765a(2).

PRAYER FOR RELIEF

WHEREFORE, Plaintiffs requests that this Honorable Court enter the proposed Order to Show Cause attached hereto as **Exhibit E**, and that it enter a judgment as follows:

- a. A declaratory judgment that Defendants are violating their clear legal duties under MCL 168.674(2), MCL 168.674(5), and MCL 168.765a(2);
- b. A writ of mandamus compelling Defendants to satisfy their clear legal duties by:
 - i. Appointing as election inspectors for the upcoming November 2022 general election the individuals set forth in the list attached hereto as **Exhibit S**;
 - ii. Reallocating no fewer than 20 Republican election inspectors from precinct polling places to the City's AVCBs;
 - iii. Reallocating no fewer than 25 Republican election inspectors as chairpersons;

- iv. Taking affirmative actions to recruit additional Republican election inspectors, including but not limited to educating City staff about the requirement to recruit and appoint Republican election inspectors, and publicly posting a call for Republicans to volunteer to serve as election inspectors; and
 - v. Assisting each prospective Republican election inspector that contacts the City to inquire about serving in that role in a manner consistent with this Board's ongoing duty under MCL 168.674(5), rather than turning those individuals away.
- c. Any other relief this Court deems just and equitable.

Dear Commissioners,

We are counsel for the Michigan Republican Party and the Republican National Committee (collectively, the "GOP"). We write to you in your capacity as members of the Flint Board of Election Commissioners (the "Board"), and specifically regarding the insufficient number of Republican-affiliated election inspectors that have been appointed by the Board to serve as inspectors in the quickly-approaching general election.

In light of the departure of former-Clerk Inez Brown, with whom we and our clients communicated about this matter on countless occasions, we've provided here a brief summary and background of this matter.

As you are no doubt aware, Michigan law expressly requires that this Board "**shall** appoint an equal number, as nearly as possible, of election inspectors in each election precinct from each major political party." MCL 168.674(2) (emphasis added). Likewise, the Board's legal duty to appoint an equal number of election inspectors from each major political party also applies with equal force to Flint's Absent Voter Counting Boards ("AVCBs"). See MCL 168.765a(2) (providing that the requirements for the

appointment of equal numbers of election inspectors from each major political party, among other requirements under section 674, “apply to the appointment of election inspectors to [AVCBs.]”).

Importantly, the Board’s legal duty to appoint an equal number of election inspectors from each major political party to each election precinct and to each AVCB runs through Election Day. MCL 168.674(5).

Election inspectors play an important role in instilling confidence in our electoral process. While there may have been a shortage of Republican election inspectors in previous election cycles, this year the GOP has made a concerted effort to work with the City of Flint to assist in recruiting inspectors and collaboratively assist the City in fulfilling its obligations under MCL 168.674. For example, on May 12, 2022, the GOP provided former-Clerk Brown with applications for 122 Republicans interested in serving as election inspectors in the City of Flint for the August 2, 2022 primary election. Despite the GOP’s efforts, on July 16, 2022, the City of Flint provided the Genesee County Republican Party with a list indicating that the City had hired only 27 Republican election inspectors. The City had, however, hired 442 Democrat election inspectors for the same election. It goes without saying that a 27:442 ratio is a far cry from the “equal as possible” requirement set forth under Michigan law. Making matters worse, the City of Flint hired only 4 Republican election inspectors to work at its AVCBs, compared to the 56 Democrats hired by the City for the same role.

In light of the discrepancy between the quantity of Democrat and Republican election inspectors, the GOP contacted former-Clerk Brown on July 26, 2022—one week prior to the primary election—to address the City’s unequal appointment of partisan election inspectors. Former-Clerk Brown assured the GOP that the City would contact the Republicans provided by the GOP back in May 2022. But even then, the GOP contacted those Republicans after the primary election, and learned that the City had hired only an additional 22 applicants. In sum, the ratio of Democratic election inspectors to Republican election inspectors employed by the City of Flint for the August 2022 primary election was approximately 15:1. Neither that ratio nor the Board’s effort to appoint an equal number as possible of Democrat and Republican election inspectors satisfied Michigan law.

Nonetheless, for the sake of assisting the Board in complying with its duty under Michigan law to appoint an equal number of election inspectors from each major political party to each election precinct and each AVCB, the GOP issued a letter to former-Clerk Brown on September 9, 2022, which enclosed a list of 61 Republicans that had confirmed their interest and availability to work as election inspectors during the November 2022 general election in the City of Flint. That letter also requested, as a show of good faith, written assurance that the clerk would commit to contacting and scheduling election inspector training for each person on that list. The GOP, however, never received such written assurance.

It was against that backdrop that the GOP received the list of election inspectors issued by the Board to the Chair of the Genesee County Republican Party for the upcoming November 2022 general election. A copy of that correspondence and list are attached hereto as **Exhibit A**.

Simply put, the Board’s list of election inspectors does not comply with Michigan law. Of the approximately 562 election inspectors included in the list, only 57—or approximately 10%—are

Republicans. This disparity does not comply with MCL 168.674(2). Likewise, the Board has appointed 45 Democrat election inspectors to serve at the AVCBs, compared with merely 2 Republicans for the same role. This disparity is also not compliant with MCL 168.674(2). As a further example of these unacceptable disparities, the Board has appointed 98 Democrats to serve as chairpersons, but only 2 Republicans to the same role.

Making matters worse, the GOP has learned that additional Republicans recently contacted the clerk's office to inquire about working as election inspectors. Yet, despite the disparities outlined above, those individuals were rejected by staff in the clerk's office.

In one instance, Ms. Gloria Boone, the City of Flint's Election Supervisor, informed a prospective Republican election inspector that the clerk's office had received "a lot" of calls from Republicans asking about serving as election inspectors, but Ms. Boone questioned the rumors that the City "needs more Republicans" as election inspectors because Flint "is a predominately Democratic area" and indicated that she does not need to know their partisan affiliation. That individual was directed by clerk staff to fill out and submit an application, but was left with the impression that the clerk's office did not need any more Republican election inspectors.

In light of the demonstrated numerical disparities between Republican and Democrat election inspectors identified by the Board, and the Board's clear legal duty to appoint an equal number of election inspectors from each major political party to each election precinct and to each AVCB—a duty that runs through Election Day under Michigan law, *see* MCL 168.674(5)—the intention of this letter is to assist the Board in good faith with bringing its appointment of election inspectors into compliance with Michigan law.

While our Firm has been authorized to take all appropriate actions under law and equity to ensure that the clear legal duties of the Board are fulfilled as they relate to the appointment election inspectors under MCL 168.674, 168 765a, etc.,¹ we appreciate that the confluence of the departure of former-Clerk Brown and the Board's understanding of its duties under Michigan law may lead to an amicable resolution of this matter. With that in mind, the GOP respectfully requests that the Board take the following actions by 4:30pm on Tuesday, October 25, 2022:

- Appoint as election inspectors for the upcoming November 2022 general election the individuals set forth in the appended list, attached hereto as **Exhibit B**;
- Reallocate no less than twenty (20) Republican election inspectors from precinct polling places to the City's AVCBs;

¹ While Michigan law permits the county chair of a major political party to challenge the appointment of individual election inspectors based on those individuals' partisan bona fides, among other qualifications, *see* MCL 168.674(3), the Board's clear legal duty to appoint an equal number of election inspectors from each major political party to each election precinct and AVCB would be enforceable through, among other actions, a writ of mandamus commenced by an aggrieved major political party.



- Appoint no less than twenty-five (25) Republican election inspectors as chairpersons;
- Take affirmative actions to recruit additional Republican election inspectors, including but not limited to educating City staff about the requirement to recruit and appoint Republican election inspectors, and publicly posting a call for Republicans to volunteer to serve as election inspectors;
- Assist each prospective Republican election inspector that contacts the City to inquire about serving in that role in a manner consistent with this Board's ongoing duty under MCL 168.674(5), rather than turning those individuals away; and
- Cease accepting prospective Democrat election inspectors in order to permit the above-referenced actions an opportunity to work toward a more equal balance of Republican and Democrat election inspectors as required under Michigan law.

We appreciate your taking the time to consider these requests, which are firmly rooted in Michigan law, and we likewise trust that the Board shares our desire to promptly resolve this matter in a collaborative manner rather than proceeding with expedited litigation.

With that in mind, please do respond to us at cspics@dickinsonwright.com and ravers@dickinsonwright.com by 4:30PM EDT on Tuesday, October 25, 2022, to confirm the Board's compliance with these requests. Separate from that timeline, we welcome the opportunity to discuss this matter with your counsel in advance of that deadline if the Board believes such discussions would be fruitful in reaching an acceptable solution prior to 4:30 PM EDT on October 25, 2022.

Dear Mr. Spies and Mr. Avers,

The City of Flint Law Department is in receipt of your October 21, 2022 letter. Thank you for communicating your concerns to us regarding the appointment of election inspectors at the City of Flint.

As you quoted, MCL 168.674(2) conditions the appointment of equal election inspectors from each political party with the clause, "as nearly as possible." The list of election inspectors circulated on October 15, 2022, included all Republican-affiliated election inspectors who (a) submitted the necessary application,¹ (b) agreed to attend the necessary training,² and (c) were available to work the November 8, 2022 general election. This necessarily limited the number of Republican-affiliated election inspectors who could be appointed because it would violate the law to appoint election inspectors who do not satisfy the statutory requirements.

Furthermore, the Chair of the election commission, interim City Clerk Donahue, has the authority to fill vacancies in the offices of election inspector.³ I am informed that, pursuant to that authority, subsequent appointments of election inspectors have brought the total number of Republican-affiliated election inspectors to over 120. Indeed, almost 50 of the persons listed in your October 21 letter have been appointed as election inspectors.

In that vein, we would like to thank you for the additional names that you have provided in your October 21 letter. For the persons you listed that the City Clerk's Office has not already been in contact with, that office intends to contact them and inquire as to whether they remain interested in submitting the required application, attending the necessary training, and working the November 8 general election. However, we would also note that in addition to names which have already

been appointed as election inspectors, your list also includes duplicative names, names of persons who – when contacted by the City Clerk’s office – informed us that they were already working as election inspectors in other jurisdictions, and the name of at least one person who yelled profanity at the staff who contacted him and instructed our staff to not call them in the future.

Thank you for your interest in safeguarding the democratic process, and we hope that your client will continue to be interested in ensuring that every voter in Flint can fully participate in the November 8, 2022 general election.
