25 **STATE’S MOTION FOR LEAVE**  
26 **REGARDING MOTION TO DISMISS**

**MOTION FOR LEAVE**

Defendant Mark Brnovich (the “State”) respectfully moves this Court for leave to treat and file the lodged Consolidated Motion to Dismiss that was filed earlier in *Mi Familia Vota v. Hobbs*, 2:22-cv-00509-SRB (D. Ariz.) (the “Consolidated Matter”) as a Motion to Dismiss in the instant matter.

Given that the instant matter, like many challenges in the Consolidated Matter, challenges HB 2492 under the First and Fourteenth Amendments to the U.S. Constitution and the National Voter Registration Act (“NVRA”), the interests of judicial economy strongly favor briefing addressing all issues in a consolidated manner rather than in piecemeal approach. A consolidated motion to dismiss is warranted for all of the reasons explained in the State’s motion to consolidate. (Consolidated Matter Doc. 136). This Court has previously granted equivalent leave for equivalent challenges, and should do so again.
