**INTERVENOR-DEFENDANTS’ MOTION TO DISMISS**

Intervenor-Defendants support and seek to uphold free and fair elections on behalf of all Pennsylvanians. Intervenor-Defendants therefore respectfully move the Court to uphold the General Assembly’s duly enacted laws governing Pennsylvania’s elections and to dismiss Plaintiffs’ Complaint. Intervenor-Defendants submit the accompanying Memorandum of Law demonstrating that Plaintiffs’ two-count Complaint “fail[s] to state a claim upon which relief can be granted,” Fed. R. Civ. P. 12(b)(6), because the General Assembly’s duly enacted date requirement for absentee and mail-in ballots does not implicate, let alone violate, the federal materiality provision, 52 U.S.C. § 10101(a)(2)(B), and does not violate the U.S. Constitution.<sup>1</sup>

WHEREFORE, Intervenor-Defendants respectfully request that the Court GRANT this motion and DISMISS Plaintiffs’ Complaint.
