I hereby attest, that the parties involved in this voting scheme have denied, infringed upon or abridged my right to vote.

I, Kristen Lovell, have no contract relinquishing Rights or Property to the state of Georgia, nor any subdivisions thereof.

I, Kristen Lovell, DO NOT COMPLY with voting on an illegal voting machine.

I am not an expert in law, however, I do know right from wrong. If there is any man or woman damaged by any statements herein, if he will inform me by facts, I will sincerely make every effort to amend. I hereby and herein reserve the right to amend and make amendments to this

document as necessary, in order that the truth may be ascertained and proceedings justly determined.

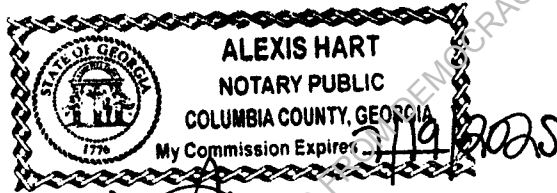
