I hereby attest, that due to the lack of certification, the fact that machine voting was never voted on by electors to replace paper ballots, and the fact that electors never voted on an increase of the indebtedness of Morgan county nor an increase of taxes in Morgan county to pay for these voting machines, that these machines are illegal and were unconstitutionally and illegally forced upon me and the People of Morgan county.

I hereby attest, that the parties involved in this voting scheme have denied, infringed upon or abridged my right to vote.

I, LORI TULLOS, have no contract relinquishing Rights or Property to the state of Georgia, nor any subdivisions thereof.

I, LORI TULLOS, DO NOT COMPLY with voting on an illegal voting machine.


