3. The Defendants will file pleas to the jurisdiction once they are served, and this Court will rule on those pleas based, at least in part, on the allegations contained within the Plaintiffs' live pleading. 4. In order to enhance the chances that this Court will deny the Defendants' pleas to the jurisdiction, Plaintiffs have been waiting on a bench verdict in an election contest filed by Erin Lunceford against Judge Tamika Craft, Cause No. 2022-79328. Judge David Peeples of Bexar County was assigned to that election contest, and yesterday he informed the parties that he will issue his verdict in early November. That ruling will play a crucial role in how this lawsuit plays out. As soon as the verdict is announced, then the undersigned will file an amended pleading within seven (7) days. Once that amended pleading is filed, then the Plaintiffs intend to serve both Defendants, at which time each Defendant is expected to file a plea to the jurisdiction.

5. Plaintiffs intend to prosecute this civil lawsuit and do not wish it to be dismissed for want of prosecution. Plaintiffs have shown good cause to retain this lawsuit on the Court's active docket.

6. This Motion is verified.

WHEREFORE, PREMISES CONSIDERED, Plaintiffs respectfully pray that this case be retained on the Court's active docket.
