**NOTICE OF SUPPLEMENTAL INFORMATION**

Proposed Intervenor-Respondent, the Pennsylvania Democratic Party (“PA Dems”), files this notice of supplemental information and avers as follows:

1. At the time the PA Dems filed its application for intervention on Thursday afternoon, the PA Dems had nominated a candidate (Joseph McAndrew) in the 32<sup>nd</sup> District relevant to this cause of action but had not completed nomination actions relevant to the 34<sup>th</sup> and 35<sup>th</sup> Districts.

2. In response to, and in reliance upon, the writs issued by Leader McClinton, and the notifications received from the Pennsylvania Department of State, the PA Dems have since taken the further relevant actions:

- a. On December 17, 2022, the relevant committee people of the Allegheny County Democratic Committee, a coordinate branch of the PA Dems, met in two separate meetings to select recommended candidates for selection as nominees of the Democratic Party in the special elections in House Districts 34 and 35.
- b. The local elected leadership selected Abigail Salisbury and Matthew Gergely as the recommended candidates for Districts 34 and 35, respectively.
- c. Beginning on December 17, and concluding on December 18, 2022, the PA Dems Executive Committee met and ratified the nominations of Ms. Salisbury and Mr. Gergely.
- d. PA Dems today filed certificates of nomination for each of Ms. Salisbury and Mr. Gergely pursuant to the Election Code.
- e. PA Dems have begun campaigning and communications in Districts 34 and 35 and have continued the efforts in District 32 begun last week.

3. Further, it has come to the attention of the PA Dems that the Pennsylvania Republican Party has filed nomination certificates for Clay Walker, Robert Pagane, and Don Nevills as Republican candidates in Districts 32, 34, and 35, pursuant to the writs issued by Leader McClinton.

The Pennsylvania Democratic Party respectfully requests that the Court consider the additional information contained herein as it considers the Petition for Intervention filed by the PA Dems.
