This matter has been brought to the Court's attention to address a number of pleadings that have been filed since the emergency portion of this case was processed around Christmas. The motion for new trial was filed in early January, but the Court has continued to receive supplemental briefings on this motion, including as recently as last week.

The Court will review all the pleadings that have been filed including the recent Supplemental Briefing for New Trial by Plaintiff and each parties' responses to those.

IT IS ORDERED granting the Motion of Arizona Senate President Warren Petersen and Speaker of the Arizona House of Representatives Ben Toma for Leave to File a Brief as *Amici Curiae*.

The Court will read all these briefings and pleadings prior to the hearing as well as case law, statutes and rules referred to within the various pleadings. As to Plaintiffs' Motion for An Order Reflecting Additional Rulings of the Court, the Court had read that motion and Defendant Mayes' response back in late December and was considering the options when the Motion for New Trial was filed. The Court will address the need for additional findings during the oral argument set on the Motion for New Trial.

IT IS ORDERED setting Plaintiff Abraham Hamadeh's Motion for a New Trial for Oral Argument on Tuesday, May 16, 2023 at 1:30 p.m.
