Washington County defendants give notice under Local Rule 42-2 that this case is related and shares similar questions of law and fact with two other elections cases that have previously been filed with this Court: *Gunter, et al. v. Gambee, et al.*, No 3:22-cv-01675-JR (D. Or.) (Gunter II) as well as 3:22-cv-01242-MO (Gunter I). The legal questions here regarding the lawfulness, certification and use of tally machines manufactured by Clear Ballot and used by

Washington County are essentially the same claims as those raised in Gunter II regarding the use and certification of the Clear Ballot Tally system in Wasco County.

Under Local Rule 42-2 “[i]t is the responsibility of counsel to identify complex or related cases and to bring the matter promptly to the attention of the Court.” Here, the Claims by plaintiffs against the Washington County defendants involve substantially similar allegations as the two aforementioned cases such that this case should be assigned to the same judge assigned to Gunter I and Gunter II to promote judicial economy and consistency.
