Subsequent to oral argument and the Plaintiffs' original Notice of Supplemental Authority, the Arizona Secretary of State published for public comment a draft of the 2023 Elections Procedures Manual. Notwithstanding suggestions from counsel for intervenor Mi Familia Vota that "the new EPM will not even include the policy being challenged," see, e.g., Intervenor-Defendant Mi Familia Vota's Reply in Support of Its Motion to Dismiss at 2 (June 30, 2023)

Mi Familia Vota's factual assertion was expressly based on a newspaper article. *See Reply* at 2. Even if hearsay evidence could be offered and admitted in support of a motion to dismiss (or in a reply brief, for that matter), there is no longer a good faith basis for maintaining the suggestion that a new Elections Procedures Manual will imminently be adopted without the relevant provision,
