PAEL LATER HELD ELSOWN DEEMOCKARCY DOCKEET, COMM.

Pursuant to Fed R. App. P. 27(a)(3), Plaintiffs file this response to Defendants' motion, Dkt. 83-1. In light of Defendants' representation to this Court that Senate Bill 2425 ("S.B. 2425") does not prohibit a person of the voter's choice from providing assistance with the collection and transmission of a ballot, unless the chosen person is among the limited exceptions identified in S.B. 2425 § 1(4), Plaintiffs do not oppose canceling the scheduled oral argument date and holding this appeal in abeyance. See Dkt. 83-1 at 9 ("Under S.B. 2425, however, disabled voters like Mr. Whitley are not limited in their choice of assistant to the specific categories included in S.B. 2358. Rather, such voters may receive assistance from 'a person of [their] choice' 'other than' their 'employer' or 'union' officials, 'a candidate whose name is on the ballot,' certain family members of candidates, or 'a poll watcher who is observing the polling place or election day.""); id. at 10 ("For similar reasons, when July 1 arrives Ms. Cunningham and Ms. Gunn will also no longer face injury from S.B. 2358. They wish to provide assistance with mail-in voting to blind, disabled, or illiterate voters and feared injury (in the form of prosecution) from S.B. 2358 for doing so."). However, Plaintiffs reserve the right to respond to any forthcoming motions regarding mootness.

After the passage of Senate Bill 2358 (codified as Miss. Code Ann. § 23-15-907), Plaintiffs obtained a court order preliminarily enjoining the implementation of the law. ROA.338. The district court held that the law likely conflicted with Section

208 of the Voting Rights Act of 1965, 52 U.S.C. § 10508, by depriving voters who have a disability, blindness, or an inability to read or write of their right to select a person of their choice to assist them in the return of their absentee mail-in ballot. ROA.338. The district court also criticized the state law as vague and lacking "guideposts" for determining the meaning of "vital terms," particularly "caregiver, family members, [and] household members." ROA.336–37.

In response to the district court's order and injunction, Mississippi passed S.B. 2425 to amend Miss. Code Ann. § 23-15-907 to address the flaws identified in the district court's order. As Defendants acknowledge, S.B. 2425 adds language—largely tracking the text of Section 208 of the VRA—exempting the provision of assistance needed by voters due to "blindness, disability, or inability to read or write." Dkt. 83-1 at 6–7. S.B. 2425 also sought to clarify the terms that the district

<sup>&</sup>lt;sup>1</sup> In the floor debate for S.B. 2425, Representative Willie Baily raised concerns about the legality of the pending legislation in light of the instant litigation and the district court's finding that S.B. 2358 impermissibly restricted voters with disabilities their choice of an assistant. Mississippi Legislature, MS House Floor – 4 April, 2024; 10:00 A.M., YouTube (April 4, 2024), https://www.youtube.com/watch?v=ChZ 1F6IYDg (debate begins at 1:02:15 mark, Baily statements begin at 1:11:48 mark) (last visited May 3, 2024). Representative Noah Sanford—the Chair of the Apportionment and Elections Committee—responded that S.B. 2425 was amended during the 2024 legislative session to guarantee voters with disabilities the right to select a person of their choice to provide assistance, and that members should vote for the amended version allowing such assistance. Id. at 1:13:45. Similarly, Senator Jeff Tate spoke on the Senate floor and explained that the amendment was intended to "clarify that if you're blind, disabled, or illiterate that you can receive assistance in voting." Mississippi Legislature, MS Senate Floor – 15 April, YouTube 2024: 4:00 PM, (April 15, 2024), https://www.youtube.com/watch?v=5pSJRup0Zx8&ab channel=MississippiLegislature (Tate statement at 35:00 mark) (last visited May 3, 2024).

court held to be vague, adding definitions for "caregiver," "family member," and "household member." Dkt. 83-2 at 3-4.

Given Defendants' interpretation of S.B. 2425 to exempt persons like the individual Plaintiffs from criminal liability, Plaintiffs do not oppose Defendants' motion to cancel oral argument and hold the appeal in abeyance.
