	R1 – Raymond United Methodist Church R2 – Hinds Comm. College Meat Dept. Or Meat Market DG – Springhill Christian Center	R1 – Multiple spaces for accessible parking, accessible machine was working; however, brick in front of one of the doors, and no poll worker outside for curb side assistance.
	10 – Galloway Elementary School C2 – Wildwood Baptist Church	R2 – Plenty of parking; more signage needed to indicate the route and which door to use; all glass so poll worker could see if curb side needed; accessible machine available.
Group 1		DG – Plenty of parking and spaces; accessible drop off marked; small ramp to main entry with steps on either side – does need at least 1 handrail.
		10 – NO curb cut at all from parking, driveway area to the entry way doors; doors were wide enough and propped open but the mechanism used to keep open were obstacles of stacked chairs and a big stone; better signage needed; had issues with accessible machine not working until approx. 11am.
		C2 – Better signage to the route needed; the pathway was clear but the doors were heavy, closed, and had hardware that required pushing down, grasping, then pulling; they needed to be propped open. Needed to mark and indicate accessible parking closer to the entry point; accessible

		machine was still being worked on at 9am; seems to be some issue with a poll worker thinking it acceptable for voters to just park where they want and to just call him when they are ready to come vote. Training needed
Group	55 – Police Training Center 22 – Fire Station #20 23 – Medgar Evers Municipal Library 30 - Faith Presbyterian Church 29 – Powell Middle School 13 – Walton Elementary School	55 - The parking area is ample but not close to the entry point; the surface is a mixture of concrete and asphalt but it's rough, and the area close to the sloping ramp is just broken up and dangerous; better signage at the entrance is needed; doors needed to be propped open due to mechanism requiring grasp push and pull.
		22 - better signage need at street; parking is confusing yet ample; the entry door has a lip of about 4 to 5 inches and no temporary ramp or wedge; the door was blocked and just a hazard area in general as voters had to step around/over a water hose, buckets on the floor, leaking ice, general clutter; no poll worker outside watching and with parking around the back; there are no curb cuts.
		23- signage needs to be improved; spaces are available but drop off might cause some traffic in a heavy voting day due to how the route is.
		30 – Better signage would be helpful but no major issues found; slightly confusing 2 nd "accessible" entrance, but the main entry point had the same accessible features so it was basically redundant.
		29 – Plenty of parking even though the incline to approach the entry door might cause a difficulty for someone in a manual chair or on crutches/walker; ramp and entry ways were spacious but the curb cut

		needs improvement – it is grassy and has a large dip in one side which could tip an electric chair over. Poll workers available and watching; needs spaces for accessible vehicle parking to be clearly marked in effort to not block the one curb cut. 13 – Problematic site; security is an issue; school doors remain locked, so voters are interspersed with students and this lends to multiple issues; the accessibility is rough; no curb cuts on the street at all, so a voter must park in a side lot that is far from the entry point, travel along the sidewalk and go up an old built in ramp that is very narrow with concrete sides and no hand rails. It is not up to any standard or code and could be dangerous.

- CH The accessible parking marked spots are the furthest away from the voting entry point; a simple wedge to address the approx. 3 to 4 inch rise in the curb and marking off 2 spaces would suffice for greater accessibility and ease of access.
- CA No accessible parking that makes sense; they have an accessible parking sign in the grass of a steep embankment; the door is not accessible because of the twist knob, should be propped open but it might block anyone trying to drive through to the parking lot; not a safe location.
- LE Door should be propped open due to twist knob.
- 09 Temporary double ramp set up for the 6 to 7" rise in front of the entry it is rickety, loose, and narrow with no handrails. They told the advocate they had a wider/larger ramp "in the back, but it had been raining, so..."; they chose not to make the effort and it was not currently raining/had not rained much; No signage on the entry door to indicate voting site.
- 18 Accessible parking is farthest from open entrance; the accessible entrance leads to a locked door. Better signage or designating some accessible spaces closer to main entrance might help.
- 06 the main entrance was not at all accessible due to stairs; any additional accessible entrance was not identifiable/did not seem to exist;

unlock the main school doors; totally inaccessible; no poll worker monitoring outside for curb side voting. Did have Express Vote going.

70- No issues noted. – However, more visible signage from road might be helpful.

68- Inaccessible spot due to shared parking with student pickup line on one side and houses/neighborhood close on the other side; signage is easily blocked; the "accessible" entrance on the side has a curb cut that's not viable due to gravel, rocks, grass; the pathway is too far and the incline of the ramp is too steep; there is broken/falling metal roofing over the walkway that seems too dangerous to traverse; no poll worker monitoring for curb side assistance.

64- Only "Vote Here" sign on the side door was being removed at 6:45pm and only put back up once advocate spoke to poll worker – training needed; the accessible entrance is around to the front of the church but no "Vote Here" sign to indicate it could be used; parking is limited with only street access; accessible doors locked.

63- Parking is on side of church if needing to use the accessible curb cut but the curb cuts were haphazardly placed and one had a cone partially blocking it; parking was difficult in the small lot and big truck was using the one marked accessible space; no one outside watching for curb side assistance needs.

59- Parking is level and super close to the front door/main entry point – but there are concrete bumpers that would create a problem for someone

		in a wheelchair having to get around or through them; entire front was glass so poll workers were watching out. 47- Great spot; plenty of flat, close parking; small walk to entry point with a concrete ramp if needed; poll worker standing by; plenty of space inside and working machines with proper equipment.

B3 – Wesleyn Trinity Church OB – Byram City Hall	TE1- Parking is adequate but needs a space designated for accessible parking closer to the path/walkway; better signage needed; door needed to be propped open; The Express Vote machine was there but not fully set up and operational at 9:45am. TE2 - adequate accessible parking and clearly marked; however they had a bench propping the door open and this created a barrier, they were asked to make a change; Express vote machine not operational at approx. 11:25 am. B2 - Parking is flat and even, but nothing specifically marked off for accessible parking; there was a 2" lip (piece of wood) at the entryway and would have created a barrier for someone in a wheelchair with limited mobility to get over. Quite possible the doorway was too narrow but would need further evaluation; door should have been propped open due to being a turn / twist knob. The Express Vote machine was not operational—they were waiting on a code at 10:40am. B3- There was ample parking, however the signage led one to believe that the shortest route to the voting area would be the spaces that were down a steep slope; but there was a viable, well-appointed accessible entrance

		that if it was designated as such, wasn't marked – better signage and planning.
		OB- This site was accessible and in good condition with no obstacles for physical access; however, they had an Express Vote machine which was not set up because, as our advocate was told, "they had never used it before." Unacceptable. Training needed.
	TN – St. Paul United Methodist Church PO - Pine Grove Missionary Baptist Church CY – Mclean Volunteer Fire Dept. 84 – China Grove Baptist Church 80 – Tougaloo Community Center	TN- gravel parking area; the walkway to the doorway is narrow, rough, and there are 2 steps, that are approx. 4" high each to enter the door; the door should have been propped open, as it is a twist/turn knob; they offer curb side but there was no poll worker watching for those who may need assistance. PO- Parking is ok; could use more signage; the door should be propped
Group XI		open as it is too heavy to maneuver for someone with limited dexterity; it is possible someone in a power chair would not be able to navigate through the door due to it being up against a wall and the door may not open wide enough for someone to easily turn into the space; the Express Vote Machine did not have all the equipment set up at 2:40pm.
1		CY- Parking was adequate and accessible; entry was wide open and flat, however, all of the equipment was not set up on the Express Vote machine.
		84- Parking is sufficient; the entry ways into the voting area are not accessible or manageable. The main voting entrance is a little side door with a step up that's approx. 3 to 4" and the double doors right next to it

		that are considered the accessible entrance were closed. At least needs a temporary wedge at both doorways, but ideally should just use the double doors since they are so close to the side entrance. 80- Ample accessible parking; curb cut might need a little maintenance to clean up but otherwise fine; doors open and flat entry; no problems indicated.
Group XII	16 – Fondren Church 38 – Chastain Middle School 37 - Boyd Elementary 39 – Fire Station #7	16- Signage too small; ramp too steep for manual chair; no earphones available for accessible machine; great parking. 38 — Double doors propped open but with the center partition left only a 28" pathway; and small lip at doorway; no sidewalk access; accessible machine working well. 37- major puddle and mud at sidewalk curb cut; Van accessible parking spot needs better marking/signage to eliminate being blocked; accessible machine not working and a cord was run over the accessible entrance; Front doors (Alternative Accessible Entrance) isn't actually accessible due to locked doors, no accessible handles, and the main door (the one which can be remotely opened) won't open all the way due to scraping the concrete. 39- Needs more efficient signage for parking; Did not have the accessible voting machine at all;
