O R D E R

The Court, en banc, having considered the briefing and oral argument in this matter, and considering the need for clarity in upcoming elections, unanimously holds that the rule-making provisions of the Arizona Administrative Procedure Act, A.R.S. § 41-1001 et seq., are inapplicable to the promulgation of the Elections Procedure Manual ("EPM") under A.R.S. § 16-452. Therefore,

IT IS ORDERED vacating the court of appeals' opinion and reinstating pages 1-3 of the trial court's May 10, 2024 decision.

IT IS FURTHER ORDERED remanding to the court of appeals to address RNC's alternative claims challenging eight specific provisions of the 2023 EPM on the basis that they contradict or directly conflict with state and federal statutes.

An opinion fully explaining our decision will follow in due course.
