ORDER TO SHOW CAUSE

Upon review of Plaintiffs' Verified Special Action Complaint for Declaratory and Injunctive Relief, Motion for Preliminary Injunction, and Application for Order to Show Cause, and good cause appearing,

IT IS HEREBY ORDERED granting Plaintiffs' Application for Order to Show Cause.

IT IS FURTHER ORDERED that all parties shall appear before the Honorable Frank W. Moskowitz on the 26th day of February 2024, at 8:30 a.m. for a 15-minute virtual return hearing to set an expedited briefing schedule in this matter.

NO TESTIMONY OR EVIDENCE WILL BE TAKEN. The Court will determine at the hearing if more time is needed, if an evidentiary hearing is necessary, or if any future dates shall be set. All parties, whether represented by attorneys or not, must be

1 present. If there is a failure to appear, the Court may make such orders as are just, including
2 granting the relief requested by the party who does appear.

3 Counsel and self-represented parties should appear promptly 5 minutes prior to the
4 scheduled time.

5
6 In the week prior to this hearing, counsel and self-represented parties will be emailed
7 information about how to access and participate in the hearing on the Court Connect
8 platform.

10 **IT IS FURTHER ORDERED** that Plaintiff shall serve a copy of the Complaint,
11 the Motion, the proposed Order Granting Motion for Preliminary Injunction, the
12 Application, and this Order on Defendant not later than three (3) business days in advance
13 of the return hearing.

14 **IT IS FURTHER ORDERED** directing all counsel and self-represented parties to
15 review the docket in this matter and to ensure that they have current, accurate email
16 addresses on file with the Court in this case.

17 **IT IS FURTHER ORDERED** directing all counsel and self-directed parties to
18 contact this division three business days before the hearing if an email containing contact
19 information for the Court Connect hearing has not been received. The contact information
20 for this division is Katrina.Berhow@jbazmc.maricopa.gov.
