FINAL JUDGMENT

THIS MATTER comes before the Court on: (i) the Order, filed March 22, 2024 (Doc. 188)(“Commission Dismissal Order”); and (ii) the Stipulation of Voluntary Dismissal with Prejudice, filed March 13, 2024 (Doc. 187)(“Stipulation of Dismissal”). In the Commission Dismissal Order, the Court dismisses Plaintiff Navajo Nation Human Rights Commission from this case without prejudice for lack of standing. See Commission Dismissal Order at 1-2. In the Stipulation of Dismissal, the parties “stipulate to the voluntary dismissal of this action with prejudice,” and notify the Court that “[t]he Parties have settled this matter pursuant to a Settlement

Agreement fully executed February 28, 2024.” Stipulation of Dismissal at 1. There being no more parties, claims, or issues before the Court, the Court enters Final Judgment, pursuant to rule 58(a) of the Federal Rules of Civil Procedure, disposing of this case.

IT IS ORDERED that: (i) the Complaint for Declaratory and Injunctive Relief, filed February 10, 2022 (Doc. 1), is dismissed; (ii) Plaintiff Navajo Nation Human Rights Commission’s claims are dismissed without prejudice; (iii) the remaining Plaintiffs’ claims are dismissed with prejudice; and (iv) Final Judgment is entered.
