Cari-Ann Burgess¹, Washoe County Interim Registrar of Voters sued in her official capacity only ("ROV"), by and through counsel, submits the following Answer to Petitioner's Petition for Writ of Mandamus ("Petition"):

Nature of the Case

- Admit that Paragraph 1 accurately quotes excerpts of NRS 293.675. The remainder of Paragraph 1 contains legal contentions, conclusions and opinions to which no response is required. To the extent a response is required, deny.
 - 2. Admit that Paragraph 2 accurately quotes NRS 293.530(1)(a).
- 3. Paragraph 3 contains legal contentions, conclusions and opinions to which no response is required. To the extent a response is required, deny.

Parties

- 4. The ROV lacks knowledge and information sufficient to form a belief as to the truth of the allegations in Paragraph 4 and therefore denies.
- 5. Admit that Public Interest Legal Foundation, Inc. is incorporated and based in Virginia. The ROV lacks knowledge and information sufficient to form a belief as to the truth of the remaining allegations in Paragraph 5 and therefore denies.
- 6. The ROV lacks knowledge and information sufficient to form a belief as to the truth of the allegations in Paragraph 6 and therefore denies.
- 7. The ROV lacks knowledge and information sufficient to form a belief as to the truth of the allegations in Paragraph 7 and therefore denies.
- 8. Admit that Respondent Burgess was appointed Washoe County Interim Registrar of Voters effective March 15, 2024, but deny she is presently performing the duties of the Washoe County Registrar of Voters. Admit Paragraph 8 accurately quotes excerpts of NRS 244.164(2) and NRS 293.503(3).

¹ Cari-Ann Burgess is on leave from her position as Washoe County Interim Registrar of Voters. Because she is sued in her official capacity only, Washoe County's answer is verified by Andrew McDonald, Deputy Registrar of Voters, who is fulfilling the duties of the Registrar of Voters in the absence of the Interim Registrar.

General Denial 1 2 The ROV denies every allegation in the Petition that is not expressly admitted herein. 3 **Affirmative Defenses** 4 The ROV asserts affirmative defenses without assuming the burden of proving any fact, 5 issue or element of a cause of action where such burden properly belongs to Petitioners. Additionally, nothing stated here is intended or shall be construed as an admission that any issue 6 7 or subject matter is relevant to the allegations in the Petition. The ROV reserves the right to 8 amend or supplement her affirmative defenses as additional facts concerning defenses become 9 known. The ROV asserts the following affirmative defenses: 10 11 1. Petitioners fail to state a claim on which relief can be granted. 12 2. Petitioners lack standing to pursue their claims. 3. Petitioners' claims are preempted or otherwise barred by the National Voter 13 14 Registration Act of 1993. 4. Petitioners fail to plead facts showing a clear legal right to mandamus relief. 15 16 5. Petitioners are not entitled to a writ of mandamus because they have an alternate, 17 adequate legal remedy available to them. 18 6. Petitioners' claims are barred by the doctrine of laches. 19 **Prayer for Relief** 20 WHEREFORE, the ROV respectfully requests that the Court: 21 1. Deny that petitioners are entitled to any relief; 22 2. Dismiss the Petition in its entirety, with prejudice; and 23 3. Grant such other relief as the court may deem just and proper. 24 25 26
