**STIPULATION OF DISMISSAL**

1 The parties hereby dismiss this action by “a stipulation of dismissal signed by all  
2 parties who have appeared.” Fed. R. Civ. P. 41(a)(1)(A)(ii).

3 This case was about the version of Arizona’s Elections Procedures Manual that  
4 the Secretary of State issued at the end of 2023 (the “2023 Manual”).<sup>1</sup> On December 22,  
5 2025, the Secretary of State issued a new version of the Manual (the “2025 Manual”).<sup>2</sup>  
6 The 2025 Manual has replaced the 2023 Manual.

7 This case was specifically about two provisions in the 2023 Manual. The first  
8 provision was Chapter 9, § III.D, titled “Preventing Voter Intimidation.” (2023 Manual,  
9 pp. 181–83.) This provision has been significantly revised in the 2025 Manual.  
10 (*Compare* 2023 Manual, pp. 181–83, *with* 2025 Manual, pp. 203–05.)

11 The second provision in the 2023 Manual at issue in this case was Chapter 13,  
12 § II.B.2, titled “Scope of Duty to Canvass.” (2023 Manual, p. 252.) This provision has  
13 been significantly revised in the 2025 Manual. (*Compare* 2023 Manual, p. 252, *with*  
14 2025 Manual, p. 283.)

15 Given the differences between the 2023 Manual and 2025 Manual, the parties  
16 jointly stipulate to dismissal of this action. The parties agree to bear their own costs and  
17 attorneys’ fees. A court order is not necessary for the dismissal. Fed. R. Civ. P.  
18 41(a)(1)(A)(ii).
