**VERIFIED COMPLAINT FOR DECLARATORY AND INJUNCTIVE RELIEF**

---

Plaintiffs the Republican National Committee, the Michigan Republican State Committee,  
Cheryl Costantino, in her capacity as Chair of the 13th Congressional District Republican

Committee and in her individual capacity as an election inspector applicant, Jodie Brown, in her capacity as Chair of the Wayne 12th Congressional District Republican Committee, and Ann Clark, in her capacity as Chair of the Wayne County Republican Committee, for their Verified Complaint for Declaratory and Injunctive Relief, state as follows:

**Parties, Jurisdiction and Venue**

1. Plaintiff Republican National Committee is the national committee of the Republican Party as defined by 52 USC § 30101(14).

2. Plaintiff Michigan Republican State Committee is the state central committee of the Republican Party established pursuant to MCL 168.597.

3. Plaintiff Cheryl Costantino is an individual citizen and resident of the State of Michigan and County of Wayne. At all times relevant to this litigation, Costantino has been the Chair of the 13th Congressional District Republican Committee.

4. Plaintiff Jodie Brown is an individual citizen and resident of the State of Michigan County of Wayne. Jodie Brown is the Chair of the Wayne 12<sup>th</sup> Congressional District Republican Committee.

5. Plaintiff Ann Clark is an individual citizen and resident of the State of Michigan and County of Wayne. At all times relevant to this litigation, Clark has been the Chair of the Wayne County Republican Committee.

6. To the best of Plaintiffs' knowledge, information and belief, Defendant Janice Winfrey is an individual citizen and resident of the State of Michigan and County of Wayne. Defendant Winfrey is the City Clerk for the City of Detroit and serves on the City of Detroit Election Commission.



7. To the best of Plaintiffs' knowledge, information and belief, Defendant Mary Sheffield is an individual citizen and resident of the State of Michigan and County of Wayne. Defendant Sheffield is the City Council President for the City of Detroit and serves on the City of Detroit Election Commission.

8. To the best of Plaintiffs' knowledge, information and belief, Defendant Conrad Mallett is an individual citizen and resident of the State of Michigan and County of Wayne. Defendant Mallett is the Corporation Counsel for the City of Detroit and serves on the City of Detroit Election Commission.

9. This Court has jurisdiction over the parties to this action pursuant to MCL 600.701.

10. This Court has jurisdiction over the subject matter of this action pursuant to MCL 600.605.

11. Venue is proper in Wayne County pursuant to MCL 600.1615.

### **General Allegations**

12. Michigan law requires election inspectors for every election. MCL 168.672.

13. Election inspectors play an essential role in Michigan elections by ensuring free and fair elections for all. They perform election duties ranging from processing voters and absentee ballots to securing voting equipment and publishing results. See e.g., MCL 168.674; MCL 168.677; MCL 168.678; MCL 168.679; MCL 168.682.

14. Section 677 of the Election Law provides that:

- (1) Except as otherwise provided in subsection (4), a precinct election inspector must be a qualified and registered elector of this state, must have a good reputation, and must have sufficient education and clerical ability to perform the duties of the office. An individual must not be appointed to a board of election inspectors unless the individual has filed an application with the county clerk or the city or township clerk in the county where the individual wishes to serve as a precinct election inspector.

(2) The application must contain the applicant's name, home address, ward and precinct registration if any, date of birth, political party affiliation, education, employment, and other experience qualifications. The application must provide a certification that the applicant is not a member or a known active advocate, as that term is defined in section 674, of a political party other than the political party entered on the application. The form of the application under this section must be approved by the state director of elections. A county, city, or township clerk may allow an applicant for precinct election inspector to file an application through an online application portal or by other electronic means. The clerk shall maintain a file of applications filed under this section and make the applications available for public inspection at the clerk's office during normal business hours. [MCL 168.677.]

15. Section 673a of Michigan's Election Law provides that:

Not later than May 15 of each year, the county chair of a major political party may submit to the city or township clerks in that county a list of individuals who are interested in serving as an election inspector in that county. The county chair may designate in the list the city or township in which each individual on the list wishes to serve. [MCL 168.673a.]

16. Section 674 of the Election Law provides, in relevant part, that:

(1) Notwithstanding any other provision of law to the contrary and subject to this section, the city and township board of election commissioners, at least 21 days before each election . . . shall appoint for each election precinct and early voting site at least 3 election inspectors and as many more as in the board's opinion is required for the efficient, speedy, and proper conduct of the election. The board of election commissioners may appoint as election inspector an individual on the list submitted by a major political party under section 673a who is qualified to serve under section 677. An appointment of an election inspector under this section is void if a properly completed application for that election inspector is not on file in the clerk's office as prescribed in section 677.

- (2) . . . The board of election commissioners *shall appoint at least 1 election inspector from each major political party and shall appoint an equal number, as nearly as possible, of election inspectors in each election precinct from each major political party* . . . Not later than 2 business days following the appointment of election inspectors under subsection (1) for elections in which a federal or state office appears, the board of election commissioners shall notify . . . the county chair of each major political party of the names and political party affiliations of appointed election inspectors and the precincts to which those election inspectors were appointed . . .
- (3) The county chair of a major political party may challenge the appointment of an election inspector based on the qualifications of the election inspector, the legitimacy of the election inspector's political party affiliation, or whether there is a properly completed declaration of political party affiliation in the application for that election inspector on file in the clerk's office . . . [MCL 168.74 (emphasis added).]

17. On May 14, 2024, a communication from Paula Gnacke-Nemeth, who was the chair of the Wayne 12<sup>th</sup> Congressional District at that time,<sup>1</sup> was submitted to Defendant Winfrey, in her capacity as City Clerk for the City of Detroit, that included a list of 675 individuals (with contact information) who were and are interested in serving as election inspectors in the City of Detroit under MCL 168.673a. (**Exhibit 1**, Wayne County GOP Letter to City of Detroit.) (**Exhibit 2**, Republican Election Inspector Nominations Detroit.)

<sup>1</sup> Under the Election Law, “[i]n all counties having or which may hereafter have 2 or more congressional districts or parts of congressional districts within the boundaries of the county, the congressional districts or a part of a congressional district within the counties shall each be considered a county within the provisions of this section for the holding of the county conventions provided for in this section, and shall be in place of the county convention.” MCL 168.592(3). Wayne County is comprised of multiple Congressional districts and parts of Congressional districts. Accordingly, as chair of a committee covering the portion of a congressional district within Wayne County, Paula Gnacke-Nemeth was a county chair of a major political party.

18. To the best of Plaintiffs' knowledge, information and belief, many if not all of the individuals identified on the Wayne County GOP's 2024 submission – including without limitation Plaintiff Costantino – were qualified to serve under Section 677.

19. To the best of Plaintiffs' knowledge, information and belief, other individuals who affiliated with the Republican Party and who contacted the City of Detroit expressing an interest in serving as election inspectors in the City were qualified to serve under Section 677.

20. To the best of Plaintiffs' knowledge, information and belief, many of the individuals identified on the Wayne County GOP's 2024 submission, including Plaintiff Costantino, and other individuals affiliating with the Republican Party, submitted or requested an Election Inspector Application for the City of Detroit that would begin the application process under Section 677 of the Election Law.

21. Plaintiff Costantino has been previously approved and appointed to serve as an election inspector in the City of Detroit in prior elections and expressed to City of Detroit officials her interest in serving again for the August 6, 2024 election. She was never contacted by anyone from the City of Detroit to serve.<sup>2</sup>

22. By operation of Section 674(1), election inspectors for the August 6, 2024 primary election could be appointed no later than July 16, 2024.

23. On July 10, 2024, Gnacke-Nemeth was contacted by an employee of the City of Detroit and asked to provide additional names of Republicans who were interested in serving as election inspectors. This request caused Gnacke-Nemeth to conclude that the City Clerk and the

<sup>2</sup> The City of Detroit Election Commission Report lists a "Cheryl Costantino," a Democrat, in Precinct 93. (Exhibit 3, City of Detroit Election Commission Report.) It is not clear if this is a different person, or if the City of Detroit mistakenly listed Plaintiff Costantino as a Democrat. In any case, Plaintiff Costantino was never contacted by the City of Detroit regarding being appointed to serve as an election inspector.

Election Commission did not have sufficient Republican applicants whose appointment would satisfy the “equal number, as nearly as possible” requirement of Section 674(2).

24. However, the very next day, the board of election commissioners provided the notification required under MCL 168.674, of the names and political party affiliations of appointed election inspectors and the precincts to which those election inspectors were appointed for the August 6, 2024 primary election. (**Exhibit 3**, City of Detroit Election Commission Report.)

25. Of the 335 precincts in Wayne County for which information was provided, 300 failed to abide by MCL 168.74, which requires the appointment of “an equal number, as nearly as possible, of election inspectors in each election precinct from each major political party.” (*Id.*)<sup>3</sup> Even worse was the disparity with leadership positions, with chairpersons for only 32 of the 335 precincts being filled by Republicans. (*Id.*)

26. In addition, of these 300 precincts that did not comply with the parity requirement under MCL 168.674, 202 precincts did not have *any* Republican election inspectors, despite the statute requiring “at least 1 election inspector from each major political party.” (*Id.*)

27. Most of the individuals from the list submitted by Gnacke-Nemeth, including Plaintiff Costantino, were not appointed. (Exs. 2, 3.)

28. The City of Detroit Election Commission only appointed a total of approximately 310 Republican inspectors but appointed approximately 2,337 Democrats. (Ex. 3.) Only 52 of the 675 Republicans nominated by Gnacke-Nemeth comprised the 310 Republican inspectors, leaving a total of 623 nominated Republicans who were not appointed. (Exs. 2, 3.)

29. In addition, Plaintiffs have identified 51 Republicans who received some communication from a City of Detroit official about being appointed, but whose names were not

<sup>3</sup> It appears from the Report that the City of Detroit has 502 election precincts; however, information regarding the appointment of election inspectors was only provided for 335 precincts.

included on the final list of appointed election inspectors. (**Exhibit 4**, Wayne GOP Received Communications List.)

30. Accordingly, the ratio of Democrats to Republicans – 7.5 to 1 – appointed as election inspectors by the City of Detroit Election Commission in the aggregate is not “an equal number, as nearly as possible”, as required by Section 674(2) of the Election Law.

31. Section 674(3) provides a limited basis on which the county chair of a major political party may object to qualifications of an appointed election inspector, the legitimacy of an election inspector’s party affiliation, or whether a particular election inspector has filed a proper declaration of party affiliation. However, Section 674(3) does not provide a remedy for the Election Commission’s failure to fulfill its duty to appoint “at least 1 election inspector from each major political party” and to “appoint an equal number, as nearly as possible...of election inspectors...from each major political party” under 674(2).

32. Plaintiffs, all of whom have suffered a special injury as the result of the Defendants’ failure to comply with their obligations under the Election Law, and have a substantial interest in Defendants’ compliance with their obligations in the future therefore bring this action seeking both a declaration that Defendants’ past practices did not ensure appointment of at least 1 election inspector from each major political party and the appointment of an equal number, as nearly as possible of Republican and Democrat election inspectors, and a writ of mandamus compelling Defendants to adopt practices and procedures to ensure compliance in the future.

#### **COUNT I: DECLARATORY JUDGMENT**

33. Plaintiffs incorporate herein by reference the allegations contained above as if fully set forth herein.

34. Defendants are required by Section 674(2) of the Election Law to “appoint at least 1 election inspector from each major political party” and “an equal number, as nearly as possible, of election inspectors” in each election precinct from each major political party.

35. In connection with the August 6, 2024 primary election, the City of Detroit Election Commission appointed approximately 2,337 Democrat election inspectors and only approximately 310 Republican election inspectors resulting in 300 of the 335 precincts failing to achieve “an equal number, as nearly as possible” of election inspectors from each major political party and 200 of the 335 precincts failing to have even a single Republican election inspector, despite the fact that qualified Republicans applied or were identified but were not pursued or selected.

36. The 7.5 to 1 ratio of Democrats to Republicans that resulted in the lack of parity within 300 of the 335 precincts violated the Election Commission’s statutory duty to appoint “an equal number, as nearly as possible” of election inspectors in each election precinct from each political party.

37. The failure of the Election Commission to appoint a single Republican in 200 of the 335 precincts violated the Election Commission’s statutory duty to “appoint at least 1 election inspector from each major political party . . . in each election precinct . . . .”

38. There is an actual controversy between the parties as to whether the Defendants complied with their statutory obligations in appointing election inspectors in connection with the August 2024 primary election.

WHEREFORE, Plaintiffs request that the Court declare the rights of the parties and enter and order pursuant to MCR 2.605 stating that:

A. Defendants’ failure to appoint Republican applicants who are qualified under Section 677 of the Election Law and instead appointing a disproportionate number of Democrats

as election inspectors in at least 300 election precincts for the August 6, 2024 primary election violates' Defendants' duty to appoint an "equal number as nearly as possible" under applicable law;

B. Defendants' failure to appoint any Republican applicants who are qualified under Section 677 of the Election Law in 200 of the reported 335 precincts violated the Election Commission's statutory duty to "appoint at least 1 election inspector from each major political party . . . in each election precinct . . . ."

C. In order to satisfy its statutory obligations in the future, the City of Detroit Election Commission must implement appropriate practices and procedures; including:

i. Within fourteen (14) days after receiving a list of individuals who are interested in serving as election inspectors in the City of Detroit from a county, state, or federal major political party, contact (which includes a medium that allows delivery confirmation, such as email or other electronic means) all individuals identified on those lists and provide them with all the required application materials and copy the major party political party official who submitted the list on such communications;

ii. Within twenty-eight (28) days after receiving a list from a county, state, or federal major political party, provide notice to the major political party official who submitted the list that identifies the individuals who have not responded, so that contact information can be verified and the major political party can assist the individuals in submitting the necessary information to the City of Detroit;

iii. Treat nominees and appointed inspectors (including perennial inspectors) from different major political parties equally throughout the process, including in filling leadership positions among election inspectors within precincts;

iv. If all inspector slots are filled but there continues to be precincts with either no member of one of the major political parties appointed or precincts with a more-than-one-inspector discrepancy in partisan parity, appoint additional qualified inspectors from the major political party that is underrepresented for each precinct until all precincts meet the parity requirements under the Election Law;

v. Review lists of additional names of prospective election inspectors submitted by officials from a major political party and pursue those prospective inspectors until three (3) days before the deadline for appointment; and,



vi. If any applicant is not appointed, state in writing the reason that the applicant was not appointed.

D. Granting any other relief that the Court deems just.

## **COUNT II: WRIT OF MANDAMUS**

39. Plaintiffs incorporate herein by reference the allegations contained above as if fully set forth herein.

40. A writ of mandamus is appropriate when (1) the plaintiff has a clear legal right to the performance of the specific act sought to be compelled; (2) the defendant has a clear legal duty to act in the manner requested; and (3) the act to be compelled is ministerial.

41. Under Section 674(2) of the Election Law, a county board election commissioner is required to “appoint at least 1 election inspector from each major political party and shall appoint an equal number, as nearly as possible, of election inspectors in each election precinct from each major political party.” MCL 168.674(2).

42. Under Michigan law, Defendants have a clear legal duty to “appoint at least 1 election inspector from each major political party and shall appoint an equal number, as nearly as possible, of election inspectors in each election precinct from each major political party” no later than October 15, 2024, in connection with the November 5, 2024 general election. *Id.*; MCL 168.674(1).

43. Plaintiffs have a clear legal right to performance of Defendants’ duty.

44. Defendants’ duty to “appoint at least 1 election inspector from each major political party” and “an equal number, as nearly as possible, of election inspectors” in each election precinct from each major political party is ministerial and does not involve the exercise of discretion, especially when Republican applicants are qualified and willing to serve.

45. Plaintiffs do not possess another legal or equitable remedy that might achieve the same result as a Writ of Mandamus.

WHEREFORE, the Committee requests that the Court issue a Writ of Mandamus:

A. Directing the City of Detroit Election Commission to implement appropriate practices and procedures to ensure the appointment of an equal number, as nearly as possible, of Republican and Democrat election inspectors; including:

i. Within fourteen (14) days after receiving a list of individuals who are interested in serving as election inspectors in the City of Detroit from a county, state, or federal major political party, contact; which includes a medium that allows delivery confirmation, such as email or other electronic means; all individuals identified on those lists and providing them with all the required application materials and copying the major party political party official who submitted the list on such communications;

ii. Within twenty-eight (28) days after receiving a list from a county, state, or federal major political party, provide notice to the major political party official who submitted the list of the individuals who have not responded, so that contact information can be verified and the major political party can assist the individuals in submitting the necessary information to the City of Detroit;

iii. Treat nominees and appointed inspectors (including perennial inspectors) from different major political parties equally throughout the process, including in filling leadership positions among election inspectors within precincts;

iv. If all inspector slots are filled but there continues to be precincts with either no member of one of the major political parties appointed or precincts with a more-than-one-inspector discrepancy in partisan parity, appoint additional qualified inspectors from the major political party that is underrepresented for each precinct until all precincts meet the parity requirements under the Election Law;

v. Review lists of additional names of prospective election inspectors submitted by officials from a major political party and pursue those inspectors until three (3) days before the deadline for appointment; and,

vi. If any applicant is not appointed, state in writing the reason that the applicant was not appointed.

B. Granting any other relief that the Court deems just.
